Statutory Licensing Sub-Committee

Procedure

Introduction

1. The Sub-Committee will conduct its hearings fairly, observing the basic rules of natural justice.
2. Each hearing will take the form of a discussion led by the Chair and cross examination will not be permitted unless the Sub-Committee considers that cross examination is necessary.
3. Hearings will be held in public but the Sub-Committee may decide to exclude the public from all or part of a hearing where it considers the public interest in doing so outweighs the public interest in the hearing taking place in public. In this context "public" includes any party to the hearing or any representative of a party.

Procedure

4. At the beginning of the meeting the Chair shall:-
 - a) ask those present to introduce themselves;
 - b) explain the procedure;
 - c) ask the parties whether they wish permission for another person to appear at the hearing.
5. The Sub-Committee will consider requests from the parties for permission for other persons to appear at the meeting. Such permission will not be unreasonably withheld.
6. The Chair will conduct the hearing taking representations from the parties in the following order:
 - a) the Licensing Officer who will outline the background to the case. The Licensing Officer's role is to provide factual information to the Sub-Committee.
 - b) the applicant/licence holder (including any person appointed to represent the party or any other persons who have been given permission to assist the party).
 - c) any party making representations (including any person appointed to represent the party or any persons who have been given permission to assist the party).

7. Before determination, the applicant/licence holder will be given the final opportunity to address the Sub-Committee.
8. Each party will be given an equal maximum period of time in which to put forward any additional information requested by the Council, to question other persons (if given permission by the Sub-Committee) and address the Sub-Committee.
9. The Sub-Committee may exclude disruptive persons in certain circumstances.
10. The Sub-Committee may adjourn the hearing in certain circumstances.
11. The Sub-Committee will ask the parties to withdraw so that it can consider its determination. In considering its determination, the Sub-Committee may ask its Legal Advisor to provide it with legal and procedural advice. The nature of this advice will be notified to the parties.
12. The Sub-Committee will make its determination at the end of the meeting and this will be confirmed in writing.

Failure of Parties to Attend a Hearing

13. If a party has informed the Council that they do not intend to attend or be represented at a hearing, the hearing may proceed in their absence.
14. Where a party has not so indicated fails to attend or be represented at a hearing the Sub-Committee may:
 - a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date; or
 - b) hold the hearing in the party's absence.
15. Where the hearing is held in the absence of a party, the authority shall consider at the hearing of the application, representation or notice made by that party.
16. Where a hearing is adjourned to a specified date the Council will notify the parties of the date, time and place to which the hearing has been adjourned.

1.0 PURPOSE OF REPORT

- 1.1 The purpose of this report is to determine a variation of a premises licence under the Licensing Act 2003.

2.0 BACKGROUND

- 2.1 An application for the variation of a premises licence has been made by Crimple Ltd, Leeds Road, Harrogate, HG3 1EW, company number 02725582. A copy of the application and associated plan is attached at appendix 1.

- 2.2 The applicants are Graham Watson and Tori Watson.

- 2.3 The application is for the following licensable activities:

Sale by Retail of Alcohol, Late Night Refreshment, Live Music, Recorded Music,

Sale by Retail of Alcohol

Sunday to Thursday 0800hrs until 2330hrs

Friday and Saturday 0800hrs until 0200hrs

Live Music

Sunday to Thursday 0800hrs until 2330hrs

Friday and Saturday 0800hrs until 0200hrs

Recorded Music

Sunday to Thursday 0800hrs until 2330hrs

Friday and Saturday 0800hrs until 0200hrs

Note: The Live Music Act 2012 removes the licensing requirement for amplified live music taking place between 0800hrs and 2300hrs before audiences of no more than 500 persons on premises authorised to supply alcohol for consumption on the premises. Background music is also exempt.

3.0 PROMOTION OF LICENSING OBJECTIVES

3.1 Section 4 of the Licensing Act 2003 places a duty on the Licensing Authority to carry out its functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

3.2 Each objective is of equal importance. It is important to note that there are no other licensing objectives, so that these four objectives are paramount considerations at all times.

4.0 REPRESENTATIONS

4.1 One representation was received from North Yorkshire Council's Environmental Protection Team on the objective of public nuisance.

4.2 This representation is attached at appendix 5.

4.3 The applicant has accepted the Environmental Protection representation in full and agreed to the conditions contained within the representation. This correspondence is attached at appendix 6.

We will continue to adhere to and promote all licensing objectives in line with our current premises licence. This will include staff training, the use of CCTV, operating a Challenge 25 age verification policy, maintaining a log of refusals/incidents, etc. As our events are private / invite only we also advise the event organiser to advise guests to pre-order taxis to try and avoid customers waiting outside.

b) The prevention of crime and disorder

As during current hours, CCTV is in use on site. SIA door supervisors would be in place should we feel the need due to numbers/type of party. We encourage pre-booking of taxis and ensure drinks are not taken out of the premises which would continue during the extended hours.

c) Public safety

All areas are regularly checked for any broken glass and would continue to be during the extended hours.

d) The prevention of public nuisance

We ensure a period of wind down with lights on, bar closed and music off allowing customers to leave at a leisurely/staggered pace rather than being asked to leave all at once.

e) The protection of children from harm

No children are allowed on site during the extended hours.

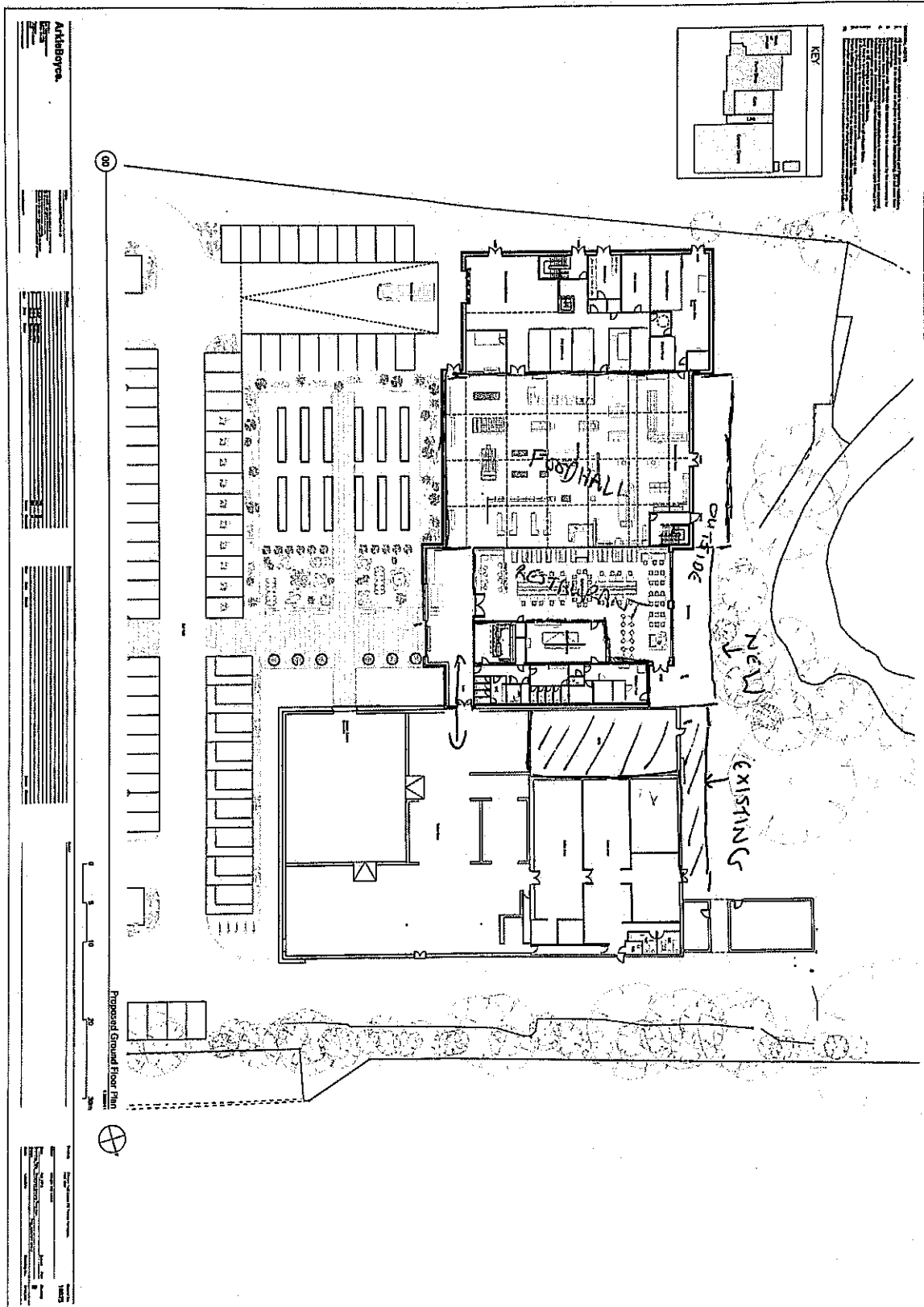

Extract from Licensing Act 2003

19 Mandatory conditions where licence authorises supply of alcohol

(1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.

(2) The first condition is that no supply of alcohol may be made under the premises licence-

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

20 Mandatory condition: exhibition of films

(1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.

(2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.

(3) Where-

(a) the film classification body is not specified in the licence, or

(b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.

(4) In this section-

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

21 Mandatory condition: door supervision

(1) Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.

(2) But nothing in subsection (1) requires such a condition to be imposed-

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or

(b) in respect of premises in relation to-



(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

(3) For the purposes of this section-

(a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

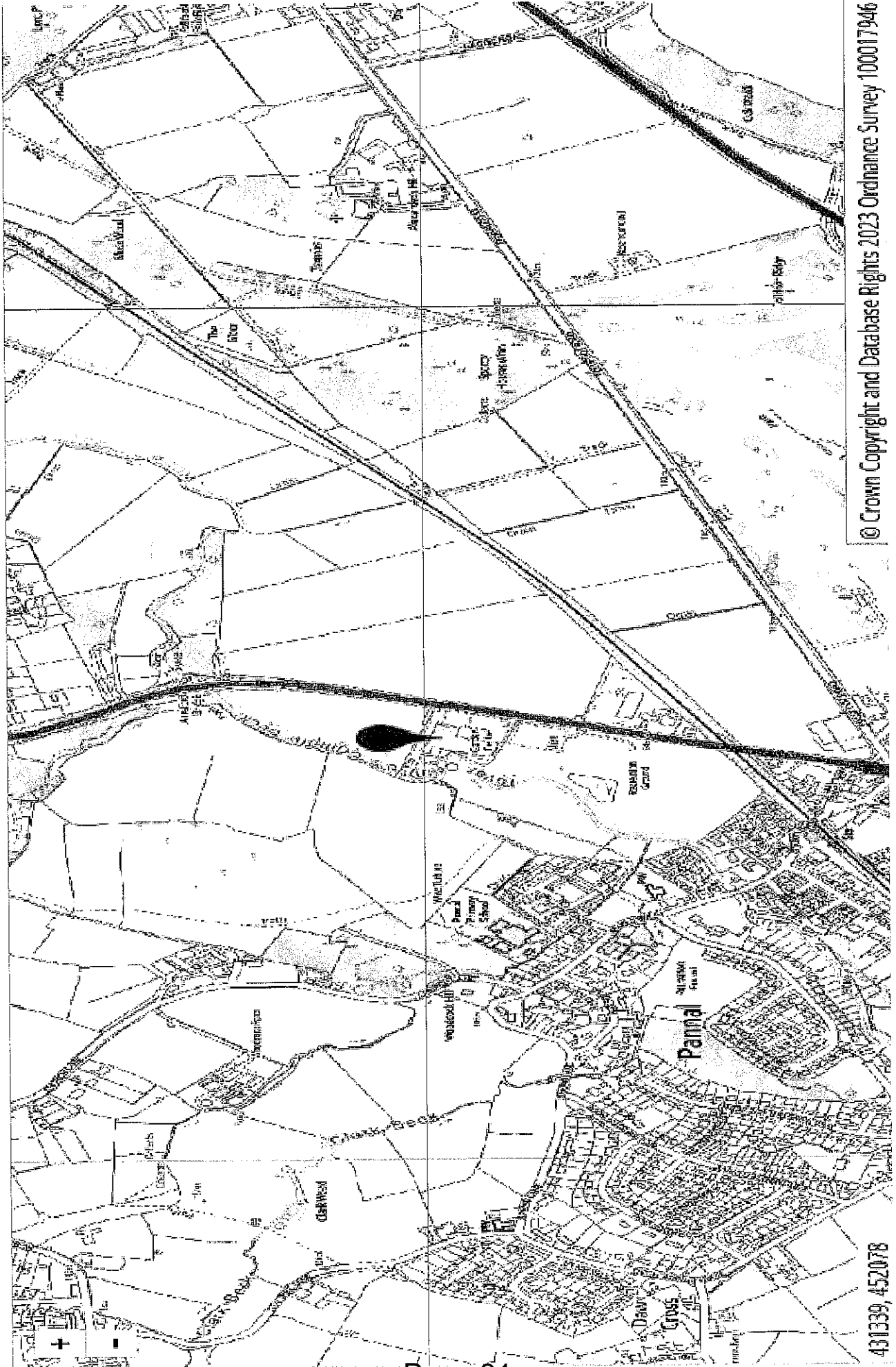

Conditions/Remedy

I understand this application is for the following: hours of opening to the public, the sale of alcohol (on and off the premises), recorded music (indoors and outdoors and live music (indoors and outdoors) Sunday to Thursday 08:00-23:30, and Friday & Saturday 08:00-02:00.

I note the applicant has stated they wish to allow live and recorded music outside. I have concerns regarding this proposal up to the times applied for as there are noise sensitive premises in proximity that could be disturbed by live and/or recorded music being played outside.

As such I would recommend the following conditions to prevent public nuisance:

1. Customers shall not use the external rear terrace of the premises for eating and/or drinking between the hours of 22:00-10:00 Monday to Sunday.
2. No speaker used to relay amplified music, singing and speech provided as part of regulated entertainment shall be positioned outside the building structure of the premises, nor shall any speaker be positioned internally such that the sound is directed through external doors, windows or other openings in the structure.
3. All external doors and windows to the room/s where regulated entertainment is being provided shall remain closed during the course of the entertainment, other than for normal access and egress.

4. All amplified music, singing and speech provided as part of the regulated entertainment shall only be played through the in-house sound amplification system.
5. Noise from amplified and non-amplified music, singing and speech arising from regulated entertainment at the premises shall be inaudible at the nearest noise sensitive properties after 23:00hrs until closing.

Informative Note:

Licensees are advised to carry out a simple "sound check" outside the nearest noise sensitive property by listening to the music etc. coming from regulated entertainment. If the music etc. is clearly audible then it is likely that this condition is being breached. Steps should then be taken to reduce the volume of the noise.

In the case of complaint or dispute and for the purpose of providing an objective standard to assess whether this condition is being complied with or not, noise shall be considered not to be audible if:

- a. the measurement of sound when music etc. is on (expressed as LAeq, 1min) does not exceed the measurement of sound (expressed as LA90, 5min) when the music is off, and
- b. the measurement of sound in each 1/3rd octave band between 40Hz and 160Hz when music is on (expressed as L10, 1min) does not exceed the measurement of sound in the same 1/3rd octave bands between 40Hz and 160Hz when music is off (expressed as L90, 5 min)

All measurements to be taken within the habitable room normally occupied at the time in question, using a Type 1 integrating-averaging sound level meter compliant with BS EN 60804, with either windows open for normal ventilation or closed, whichever situation causes greater noise disturbance.

6. Prominent, clear notices shall be displayed at all exits requesting customers and staff to respect the needs of local residents and leave the premises and area quickly and quietly. This instruction should be reinforced by staff on site when required.



Thank you for your email.

Having viewed the complaint history for your site there was a noise complaint logged in 2021 alleging loud music prior to and after 23:00hrs effecting a property 1km away. The investigation did not progress as the complainant did not provide any further information. However, it demonstrates that there is potential for complaints if the music is not managed right, and one method to help with that is the use of a single sound system.

However, I appreciate your site will have had events/weddings etc since 2021 and I am not aware of any further complaints, therefore it would appear the control measures you have had in place are working. As such based on the information, you have provided below I will remove condition 4. However, I would repeat that it is good practice to use a single sound system and perhaps this is something you can consider for the future.

Thank you for your email. We are of course happy to continue with the current conditions on our premises licence. Including that only unamplified music is allowed in the outside area and until 22:00.

The only point I have an issue with is number 4 where you stipulate that all amplified music must be played through the in-house system. We have weddings and birthday parties already booked in where the clients have booked DJs, bands, singers etc and they bring their own speakers. This is quite standard for any performing artist.

We have never had this condition on our licence and we have never had any complaints of noise. We are always respectful of our neighbours and will always continue to be. If we were to tell our clients that they effectively can't have any entertainment it will quite simply destroy the events side of our business.

I am happy to invest in a decibel sound level meter although I can assure you that we are always conscious of the sound levels and would always ask performers to reduce the sound if we felt it was too loud.

Thank you for your help on how to submit a representation against a licensing application. I would like to resubmit my objection to this application, having read your helpful guidance.

Please find below the representation from myself, Councillor John Mann, member for Oatlands, and Pannal division, North Yorkshire Council

My comments and objections below are based on preventing public nuisance, one of the aims of the council's licensing policy.

Crimble Hall is situated in an open location in Crimble Valley, and there are no natural sound barriers or mufflings to prevent sound waves, reaching All Saints Court, which comprises some half-dozen houses; and in the near future, there will be a similar number of new houses built next to this street once the current planning application for Pannal House Farm is approved.

By the same token, there is nothing to prevent sound travelling across the Pannal Sports junior football club's playing field to those residential properties (approximately 30-40 in streets off Station Road) in the centre of Pannal village.

Similarly, houses in Pannal Green backing onto the open fields in the Crimble Valley (approximately 15 to 20), and properties in Clark Beck Close (around 20) would be similarly affected.

It is my belief that sound emanating from the premises already causes a nuisance and can be heard as far afield as the properties at All Saints Court.

The location in question is open across the Crimble Valley with no sound barrier or muffling/deadening effect whatsoever to stop sound waves reaching All Saints Court – some half dozen houses plus another similar number soon to be adjoining, being the subject of a current planning application for Pannal House Farm.

Equally, there is nothing to provide sound baffle across the Pannal Sports Junior Football Club's playing field to those residential properties on streets off Station Road. Similarly, all properties in Clark Beck Close (24) and those on Pannal Green backing onto the open fields in the Crimble Valley (approximately 20) would be affected likewise. It is probable that residents on and around Stone Rings Lane would also be affected. Live music is, we understand, without exception played through performers' own amplification equipment so the stipulation governing use of Crimble's own amplification system would appear meaningless, other than for recorded music.

We note also that on and off-sales of alcohol is being requested up until 0200 on Fridays and Saturdays. One can understand a request for on-premise sales during a function up to 2300 but to suggest off-sales beyond 2300 is beyond comprehension. We believe that if such sales were permitted, it is possible, even likely, that licensing objectives 1 and 2 could also be compromised.

It should be noted that sound emanating from the premises already causes a nuisance and we trust that residents at All Saints Court will make their own representations regarding this disturbance. One resident there has stated that noise from events at Rudding Park can be heard from their homes. That is much further away than just a couple hundred metres down the hill to the Crimble complex. Proximity to the sound source is indeed one consideration but topography is also relevant. As evidenced by the Rudding Park source and also from the Harrogate Riding Centre site off Brackenthwaite Lane, where their events can clearly be heard from everywhere in Pannal village, which is more than a mile away, it would appear that the Crimble Valley is an excellent conduit for sound, acting as a loud-hailer in certain conditions.

Given the concerns expressed and even when taking into consideration the possible mitigation factors expressed by NYC in their document dated 5th July 2023, we believe that the current conditions regarding finishing times should, at a minimum, remain as they are and that music, eating and drinking outside the enclosed premises should not be tolerated under any circumstances after 2100 as it would be inevitable that doors to the main premises would be left open for access and resultant exposure to loud music. The current set-up bears no relation to that in place when the original licence application was granted. One should question the suitability of the existing licence for the current organisation let alone permit any extension.

One resident there has stated that noise from events at Ridding Park can be heard from their homes. That is much further away than just a couple hundred metres down the hill to the Crimble complex. Proximity to the sound source is indeed one consideration but topography is also relevant. As evidenced by the Ridding Park source and also from the Harrogate Riding Centre site off Brackenthwaite Lane, where their events can clearly be

heard from everywhere in Pannal village, which is more than a mile away, it would appear that the Crimple Valley is an excellent conduit for sound, acting as a loud-hailer in certain conditions.

Given the concerns expressed and even when taking into consideration the possible mitigation factors expressed by NYC in their document dated 5th July 2023, we believe that the current conditions regarding finishing times should, at a minimum, remain as they are and that music, eating and drinking outside the enclosed premises should not be tolerated under any circumstances after 2100 as it would be inevitable that doors to the main premises would be left open for access and resultant exposure to loud music. The current set-up bears no relation to that in place when the original licence application was granted. One should question the suitability of the existing licence for the current organisation let alone permit any extension.

I am the chairman of All Saints Court Residents Association. There are seven houses in the Courtyard . The residents of all seven houses are members of the Association

We object to this application on the grounds of the Prevention of Public Nuisance.

Crimple Hall lies in the bottom of the valley on the right bank of the river Crimple . From there the land rises on three sides. Open field surround it on both sides of the main road. There are individual trees along the river banks and in the fields but these and Allen Wood on Church Lane do not provide sound insulation except to Sandy Bank Cottages

The sound rises to the houses in All Saints Court, to those in the Stone Rings area, the sound reaches the rising ground of Almsford Bank to Fullwith Road and its adjoining south facing side streets, to the south to the houses in Drury Lane and Walton Place, and even to Main Street and Station Road in Pannal, Pannal Green houses and those in Clark Beck Close . There is little to buffer the noise from Crimple Hall when music is being played on their sound systems.

In All Saints Court we have noted an annoying level of sound coming from Crimple Hall in the late evening under its present licence. We object to the granting of possibility of music being allowed to be performed until much later times than at present and even after midnight. A " silent disco" rule, using bluetooth headphones, after 22.00hrs might be a helpful condition.

We object to the application to extend the hours for serving and/or selling alcoholic drinks after 23.00hrs. .
