Defra S31 Biodiversity Net Gain Grant No 31/6804

Report of the Corporate Director Community Development

1.0 Purpose Of Report

- 1.1 To recommend that the Executive Member for Open to Business following consultation with the Corporate Director of Community Development, the Corporate Director- Resources and the Assistant Chief Executive (Legal and Democratic Services) authorises the acceptance of a further £231,116 of funding from Defra to support preparations during 2023-24, for the rollout of mandatory Biodiversity Net Gain commencing in November 2023.
- 1.2 To provide context and evidence of how the grant will be spent in line with the conditions set out by Defra.

2.0 Background – Biodiversity Net Gain

- 2.1 The 2021 Environment Act provided a framework for improving the UK's natural environment over several categories including improving air and water quality, enabling nature recovery and reducing deforestation.
- 2.2 To improve biodiversity and facilitate nature recovery, three key duties and policies for local authorities were outlined:
 - **1.** <u>Biodiversity net gain</u>, a mandatory duty within the planning system to protect and enhance habitats and ensure they are not compromised by housing, employment, and infrastructure development.
 - 2. NERC (Natural Environment and Rural Communities Act 2006) Biodiversity

 <u>Duty update</u>, important enhancements to the current requirement for public
 authorities to 'have regard' for biodiversity, and an additional need to publish
 regular biodiversity reports
 - **3.** <u>Local nature recovery</u>, the planning and creation of nature recovery networks.
- 2.3 One of primary goals of the Environment Act is to protect and expand UK habitats and halt or reverse species decline by 2030. One of the policies created to reach this goal was BNG (Biodiversity Net Gain); it is the mandatory requirement for developments needing planning permission to demonstrate a 10% biodiversity net gain at the time of submission. This can include creation of new habitats or enhancement of existing habitats on development sites. Defra has confirmed that all major development will need to secure 10% BNG from November 2023, with small scale developments being brought into the scheme from April 2024.
- 2.4 In situations where 10% BNG cannot be delivered on the development site, habitat creation and/or enhancement will need to be provided offsite. These offsite BNG sites can be provided by the developer, National Government Organisation or local authority. Local planning authorities will be able to use their own land to sell

biodiversity units for this purpose, if habitat creation, restoration or management can be demonstrated, however, they will not be able to promote their own sites ahead of other biodiversity gain sites. There will also be the opportunity for developers to purchase credits from the Secretary of State if they cannot secure other off-site units, although this will be seen as a last resort.

- 2.5 All habitats created or retained that form part of the 10% (whether onsite or off site) must be secured for a period not less than 30 years to include monitoring and management. It is expected that section 106 agreements will be used to secure the long-term management obligations. Enforcement of the section 106 will be the responsibility of the Local Planning Authority. Every five years each Local Planning Authority will be required to report the losses and gains of biodiversity through the planning process.
- 2.6 Resource constraints are a big concern for local planning authorities, there is a need to prepare policy guidance, development management systems, additional ecological staff resource to review and comments on the BNG submissions, input from legal services to draw up section 106 agreements, investment in data systems to provide baseline habitat maps, systems for monitoring and reporting to Defra and resources in planning and enforcement. Additionally, there will be a need for training for all staff involved in the process and for planning committee members.

3.0 Finance

- 3.1 In March 2022, Defra provided £10,047 of grant funding in the form of a Section 31 grant to each Local Planning Authority (LPA) (County and District) to prepare for BNG. This is revenue funding intended to facilitate preparation and preparedness and was provided ahead of further resourcing confirmation associated with the full roll-out of BNG. Each of the NY authorities claimed the Defra funding and agreed to pool the funding. The pooled funding has secured a BNG Officer working full time on a fixed term contract from 1st January 2023 to 30th June 2024.
- 3.2 In March 2023, Defra offered additional revenue funding of £26,807 per North Yorkshire LPA (except Harrogate BC who received £43,467) to support ongoing preparatory work for BNG to cover the period 22-23. This funding was secured by each of the former eight North Yorkshire authorities and totalled £231,116 Defra confirmed that this funding could be carried forward into 23-24 provided that it could be ring fenced for BNG work. NYC is currently in the process of recruiting two Ecologists to work with existing staff to process the ecological aspects of planning applications, with a focus on BNG. Evidence will be provided to Defra to demonstrate how the grant has been used.
- 3.3 On 4th August 2023, Defra offered additional revenue funding of £231,116 to North Yorkshire Council (using the same funding formula as the previous year considering each of the eight former authorities). This funding will be paid as a Section 31 grant and is intended to cover work undertaken during the period 1st April 2023 31st March 2024 and continues to be in support of the preparation and implementation of new BNG burdens. There is no match funding required as a result of accepting the grant. It should be noted that Defra have requested evidence of spend against the 22-23 burdens funding alongside acceptance of the 23-24 grant.
- 3.4 Evidence can be provided in the form of newly created job roles (which have recently been through job evaluation) and agreement to recruit to these posts in the next few weeks. The intention is to recruit 2 members of staff for a fixed term period making use of the full £231,116 allocated and carried forward from the 22-23 funding.

- 3.5 In terms of a plan for spending the recently offered £231,116 for 23-24, no formal decision has been made, as the offer has only just been received with no advance warning from Defra. However, an early consideration would be to utilise funding to extend the contract of the BNG Officer who is in post until 30th June 2024, commissioning of work from NEYEDC (North & East Yorkshire Ecological Data Centre) to support BNG strategic significance mapping, buying in of bespoke training in particular on the legal aspect of BNG. The funding could also be used to extend the contracts of the two members of staff that are in the process of being recruited on fixed term contracts. Records of spend will be kept with evidence being provided to Defra against each funding period.
- 3.6 Evidence as set out above for the period 22-23 (para 3.4) will be supplied to Defra alongside or following the grant acceptance form within Annex C (ii) template provided by Defra.

4.0 Legal

4.1 The Grant conditions have been reviewed by NYC legal services.

5.0 Equalities

- 5.1 An Equalities Impact Assessment has been completed this is appended to this report.
- 5.2 No equalities issues are raised by the matters addressed in this Report.

6.0 Climate Change

- 6.1 A Climate Change Impact Assessment has been completed that is appended to this report.
- 6.2 The matters addressed in this report do not directly impact on the Council's response to climate change. However, improvements to nature recovery and biodiversity arising from implementation of mandatory Biodiversity Net Gain, are likely to be beneficial both in terms of helping to mitigate further damaging climate change and in helping the natural environment adapt to unavoidable climate change impacts.

7.0 Recommendations

- 7.1 Approval is sought for the following matters:
 - i. That the Executive Member for Open to Business, following consultation with the Corporate Director of Community Development, the Corporate Director -Resources and the Assistant Chief Executive (Legal and Democratic Services) authorises acceptance of a further Section 31 Grant of £231,116 offered by Defra to support ongoing work on mandatory Biodiversity Net Gain.

Section 31 (Local Government Act 2003) Grant Determination Letter for Biodiversity Net Gain Grant 2023/24: Grant No. 31/6804

This Determination is made between:

- (1) The Secretary of State for Environment, Food and Rural Affairs and
- (2) The local authorities listed at Annex A.

Background

Biodiversity net gain (BNG) is an approach to development that leaves biodiversity in a measurably better state than before. This means protecting existing habitats and ensuring that lost or degraded habitats are compensated for by enhancing or creating habitats that are of greater value to wildlife and people.

The Environment Act 2021 includes provisions that make the achievement of 10% biodiversity gain mandatory for most developments under the Town and Country Planning Act 1990. The requirement is due to come into force in November 2023 for most developments (unless exempt) and for small sites from April 2024.

Purpose of the Grant

The purpose of this grant is to provide funding to the local authorities in England listed at Annex A, towards expenditure lawfully incurred or to be incurred by them in delivering biodiversity net gain. Any further funding for this purpose, beyond this period, would be confirmed in due course.

Grant amounts

The grant covers the 12-month period from 1 April 2023 to 31 March 2024.

The funding allocated for the 2023/24 grant is a maximum of £11.06 million; this
includes additional funding to allow authorities that were unable to claim their
2022/23 grant to spend an equivalent amount in 2023/24. There is also up to £4.26

million further funding available to allow LPAs who are holding funds in a ring-fenced reserve from 2022/23 to spend up to this allocation in 2023/24.

The grant amount for each local authority includes funding for one off set up and preparation costs for BNG assessment between 1 April 2023 and 31 October 2023 and early operation of BNG from November 2023 – 31 March 2024.

Local authorities have been placed in one of two bands, with the amount per authority listed at Annex A.

Band	2023/24
Band 1 (authorities with 500 or fewer applications of types that fall within the scope of BNG)	£26,807
Band 2 (authorities with 501 or more applications of types that fall within the scope of BNG)	£43,467

This grant is subject to conditions, which can be found at Annex B. This requires that LPAs spend any funding held in the ring-fenced reserve first before further funding is accessed.

Payment of the grant will be made in arrears. Details of how to claim the grant will be provided on receipt of the grant acceptance.

Biodiversity Net Gain Grant GRANT DETERMINATION 2023/2024: No. 31/6804

The Secretary of State for Environment, Food and Rural Affairs (Rt Hon Thérèse Coffey MP) ("the Secretary of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the Biodiversity Net Gain Grant Determination 2023/2024 [No.31/6804].

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them to apply a minimum 10% increase in biodiversity to planning permissions (unless otherwise exempt) granted under the Town and Country Planning Act 1990.

Determination

3) The Secretary of State determines as the authorities to which the grant is to be paid and the amount of grant to be paid, the authorities and the amounts set out in Annex A.

Grant conditions

4) Pursuant to section 31(3) and 31(4) of the Local Government Act 2003, the Secretary of State determines that the grant will be paid subject to the conditions in Annex B.

Treasury consent

5) Before making this determination in relation to local authorities in England, the Secretary of State obtained the consent of the Treasury.

UK Government Branding

- 6) The Grant Recipient shall at all times during and following the end of the Funding Period:
- 6.1 comply with requirements of the Branding Manual in relation to the Funded Activities; and
- 6.2 cease use of the Funded by UK Government logo on demand if directed to do so by the Authority.
- 7) **Branding Manual** means the HM Government of the United Kingdom of Great Britain and Northern Ireland 'Funded by UK Government branding manual' first published by the Cabinet Office in November 2022 and is available at:

GRANT CONDITIONS

1. The funding must only be used by the local authority ("the authority") between 1 April 2023 and 31 March 2024 to deliver measures that apply at least a 10% biodiversity net gain, as introduced in the nvironment Act 2021 to planning permissions (unless otherwise exempt) granted under the Town and Country Planning Act 1990.

¹Funds in column D were distributed to local authorities in 22/23 financial year and are held by the local authority in a ring-fenced reserve to be used by the authority within the period 01/04/2023 to 31/03/2024.

²Grant amounts for 2023/24 for the four new local authorities that were created on 01/04/2023 include the grant amounts that the authorities they replaced would have been allocated.

³Funds held in ring-fenced reserves by local authorities that were replaced by the four new local authorities on 01/04/2023 are provided for information. These funds will be managed by the relevant new local authority.

- 2. Any funds allocated to the authority held in a ring-fenced reserve and held by the authority under the allocation of the Biodiversity Net Gain Grant Determination 2022/2023 No.31/6499 can be used by the authority within the period 1 April 2023 and 31 March 2024.
- 3. When incurring eligible expenditure, the authority must first apportion expenditure to the ring-fenced reserve held under the conditions of Biodiversity Net Gain Grant Determination 2022/2023 No.31/6499 in so figure as the authority holds it. The ring-fenced reserve must be spent in full before funds in column C of Annex A can be accessed.
- 4. An authority must confirm agreement to the grant conditions, by completing the grant acceptance form at Annex Canada sending to SM-Defra.NetGain@defra.gov.uk by 31 August 2023.
- 5. An authority must provide updates of evidence of spend incurred against the condition in paragraph 1 and any use of the ring-fenced reserve in paragraph 2, by completing the evidence form provided at Annex C and sending to <u>SM-Defra.NetGain@defra.gov.uk</u> by:
 - 15 September 2023 for the period 1 April 2023 to 31 August 2023;
 - 15 March 2024 for the period 1 September 2023 to 31 March 2024.

Eligible expenditure

- 6. Eligible expenditure means payments made by the authority or any person acting on behalf of the authority, between 1 April 2023 and 31 March 2024, for the purposes as set out in paragraph 1.
- 7. If the authority incurs any of the following costs, they must be excluded from eligible expenditure:
 - a) contributions in kind
 - b) payments for activities of a political or exclusively religious nature
 - c) depreciation, amortisation or impairment of fixed assets owned by the authority
 - d) input VAT reclaimable by the authority from HM Revenue & Customs
 - e) interest payments or service charge payments for finance leases
 - f) gifts, other than promotional items with a value of no more than £10 in a year to any one person
 - g) entertaining (Entertaining for this purpose means anything that would be a taxable benefit to the person being entertained, according to current UK tax regulations)
 - h) statutory fines, criminal fines or penalties
- 8. The authority must not deliberately incur liabilities for eligible expenditure before there is an operational need for it to do so.
- 9. If an authority is unsure if expenditure planned is considered eligible expenditure they should contact the Department for Environment, Food and Rural Affairs ("the

Department") at <u>SM-Defra.NetGain@defra.gov.uk</u> before spending those funds so the Department can confirm if it would be considered eligible expenditure.

10. For the purpose of defining the time of payments, a payment is made by the authority when money passes out of its control (or out of the control of any person acting on behalf of the authority). Money will be assumed to have passed out of such control at the moment when legal tender is passed to a supplier (or, if wages, to an employee), when a letter is posted to a supplier or employee containing a cheque, or an electronic instruction is sent to a bank to make a payment to a supplier or employee by direct credit or bank transfer.

Payment arrangements

- 11. Grant will be paid in arrears on receipt of an invoice.
- 12. If at any time the authority becomes aware that payment in arrears is not suitable due to financial arrangements within the authority, the authority must inform the Department as soon as possible. The Secretary of State reserves the right to alter the timing of grant payments accordingly.

Financial Management

- 13. The authority must maintain a sound system of internal financial controls.
- 14. If the authority has any grounds for suspecting financial irregularity in the use of any grant paid under this funding agreement, it must notify the Department immediately, explain what steps are being taken to investigate the suspicion and keep the Department informed about the progress of the investigation. For these purposes "financial irregularity" includes fraud or other impropriety, mismanagement, and the use of grant for purposes other than those for which it was provided.

Records to be kept

- 15. The authority must maintain reliable, accessible and up to date accounting records with an adequate audit trail for all expenditure funded by grant monies under this Determination.
- 16. The authority and any person acting on behalf of the authority must allow:
 - a) the Comptroller and Auditor General or appointed representatives; and
 - b) the Secretary of State or appointed representatives;
 - free access at all reasonable times to all documents (including computerised documents and data) and other information as are connected to the grant payable under this Determination, or to the purposes for which grant was used, subject to the provisions in paragraph 18.
- 17. The documents, data and information referred to in paragraph 16 are such which the Secretary of State or the Comptroller and Auditor General may reasonably require for the purposes of his financial audit or any department or other public body or for carrying

- out examinations into the economy, efficiency and effectiveness with which any department or other public body has used its resources. The authority must provide such further explanations as are reasonably required for these purposes.
- 18. Paragraphs 16 and 17 do not constitute a requirement for the examination, certification or inspection of the accounts of the authority by the Comptroller and Auditor General under section 6(3) of the National Audit Act 1983. The Comptroller and Auditor General will seek access in a measured manner to minimise any burden on the authority and will avoid duplication of effort by seeking and sharing information with the Audit Commission.

Breach of Conditions and Recovery of Grant

- 19. If the authority fails to comply with any of these conditions, or if any overpayment is made under this grant or any amount is paid in error, or if yo of the events set out in paragraph 20 occurs, the Secretary of State may reduce, suspend or withhold grant payments or require the repayment of the whole or any part of the grant monies paid, as may be determined by the Secretary of State and notified in writing to the authority. Such sum as has been notified will immediately become repayable to the Secretary of State who may set off the sum against any future amount due to the authority from central government.

Evidence of spend against ring fenced Biodiversity Net Gain Grant Determination 2022/2023 No.31/6499

The authorities came together on 1st April 2023 into North Yorkshire Council. We have been working hard to spend the ring fenced funding. The authorities prior to 1st April 2023 agreed to use the funding to employ planning Ecologists to focus on the processing of planning applications in relation to Biodiversity Net Gain. In April 2023 job descriptions for an Ecologist and Assistant Ecologist post were drawn up and have been submitted for job evaluation to determine the grade (which in turn determines the financial cost over the contract period) and how long the authority could employ these posts for. Due to the large number of staff requiring job evaluation of their roles across the legacy eight authorities it has taken longer than normal to get these posts assessed. We now have these jobs graded and are in a position to recruit at the start of September, with the intention of having new officers in post in advance of Nov 23 mandatory BNG commencement. These posts will join our existing BNG Officer (who was funded from the March 22 round of BNG burdens funding).

Having just received news of the next round of funding, it is noted that the ring fenced funds from March 23 have to be spent before the August 23 grant can be accessed. This was not known in March 23 when the funds were put into ring fenced reserves and was only notified to the authority on 4th August 23, when this round of grant funding was offered.

New Ecologist role (job description can be provided) – Grade J/K – intention to recruit on a full time, fixed term contract for 3 years.

New Assistant Ecologist role (job description can be provided) – Grade H – intention to recruit on a full time, fixed term contract for 2 years.

These calculations take in account NYC pay policy in terms of annual increments, NI, pensions and an assumed national pay award.

Ecologist 1FTE for 3 years = £152,720.77

Assistant Ecologist 1FTE for 2 years = £ 78,426.96

Implementation of mandatory BNG is a new statutory provision under the Environment Act 2021.

Defra provided £10,047 of funding to start work on BNG preparation in March 2022 – that offer was accepted by NYCC and the seven former borough and district Councils of NYs. A further allocation of £231,116 of revenue funding across the eight authorities was received from Defra in March 2023 to cover work undertaken in the financial year 1st April 2022 to 31st March 2023. On 4th August 2023 Defra offered a further revenue grant to NYC of £231,116 to support the authority in work undertaken (and to be undertaken) between 1st April 2023 and 31st March 2024. Authorisation is now sought to accept this additional funding which will further support preparatory work on BNG in advance of the mandatory roll out in November 2023 and support implementation of BNG which is an ongoing requirement.

What impact will this proposal have on council budgets? Will it be cost neutral, have increased cost or reduce costs?

£231,116 of additional grant funding will be paid to NYC as a Section 31 revenue grant. Together with the initial grant funding of £10,047 paid in March 2022 and the collective £231,116 received in March 2023, this means the funding provided for preparatory and implementation work on BNG will total £472,279.

Implementation of BNG will be undertaken to Defra standard. Defra are currently working to release the BNG metric, which will be used by all England Planning Authorities. Mandatory BNG will be enacted by changes to secondary legislation, which will be accompanied by a set of guidance. Defra and Natural England are working with the Chartered Institute of Ecology and Environmental Management (CIEEM) to produce this guidance. As BNG is mandatory, NYC will be working to this legislation and guidance.

Acceptance of this further funding to support preparatory and implementation work on BNG will not have any direct climate change impacts.
