#### **APPROVAL TO ACCEPT AN OFFER OF GRANT FUNDING – UP TO £500,000**

Report of the Assistant Director – Children and Families Service

#### **1.0 PURPOSE OF THE REPORT**

- 1.1 To recommend that the Executive Member for Children and Families, in consultation with the Chief Finance Officer, and the Executive Member for Finance authorise the acceptance of an increased offer of grant funding from the Department for Education's 'Sector Led Improvement Partner (SLIP)' Programme up to a total sum of £500,000.

#### **2.0 BACKGROUND**

- 2.1 In September 2023, the Department for Education (DfE) announced funding for a further SLIP Programme which will run during 2024-2025.
- 2.2 On 17<sup>th</sup> October 2023, NYC received approval to apply for grant funding up to £350,000 from the Executive Member for Children and Families and Assistant Director- Resources.
- 2.3 On receipt of the DfE's final funding criteria for 2024/2025 NYC calculated and submitted a bid for a final funding figure for up to £325,000.
- 2.4 On 21<sup>st</sup> December 2023, the DfE wrote to NYC to confirm in writing that their bid has been successful.
- 2.5 On 16<sup>th</sup> January 2024, the Executive Member for Children and Families in consultation with the Chief Finance Officer and the Executive Member for Finance, authorised the acceptance of grant funding for up to £325,000 from the DfE under the Sector Led Improvement Partner Programme.
- 2.6 Subsequently, the DfE have since made NYC aware of some additional funding that may be applied for by the three 'innovator' LAs from their Strengthening Families Protecting Children's (SFPC) Programme – of which NYC are one. This is with the purpose of maintaining the legacy and learning of the innovation models, including NYC's 'No Wrong Door'.
- 2.7 The DfE have invited NYC to adjust their SLIP grant funding figure from £325,000 in order to increase the available number of NYC support days. This would be to specifically incorporate work with LAs identified as those who would learn and benefit from No Wrong Door, as part of the DfE SFPC Programme legacy.

#### **3.0 FINANCIAL IMPLICATIONS**

- 3.1 The DfE have confirmed NYC will decide how we manage our resources within the additional funding, across SLIP and SFPC legacy work, meaning we are able to ensure the scope of work to be delivered is manageable in terms of resources and capacity to deliver the Programme.
- 3.2 NYC have already received approval to accept £325,000. NYC are proposing to consider accepting additional grant funding of up to an additional £175,000 to and to attain the associated funding required to cover costs and contribute to wider council benefits.
- 3.3 If approval to accept this is received, the total amount funding that would be accepted during 2024/2025 would be up to £500,000.
- 3.4 The DfE have confirmed any additional funding will continue to be paid through the existing SLIP Programme and via a Section 14 Grant.

#### **4.0 LEGAL IMPLICATIONS**

- 4.1 The DfE terms and conditions have been reviewed by legal services.

#### **5.0 IMPACT ON OTHER SERVICES/ORGANISATIONS**

- 5.1 The purpose of this report is to seek approval to accept an increased offer of grant funding from the DfE.
- 5.2 NYC's participation will be to support local authorities external to North Yorkshire and therefore there will not be any impact on North Yorkshire service provision.

#### **6.0 EQUALITIES IMPLICATIONS**

- 6.1 There are no direct equalities implications arising from this report. Consideration for equalities issues have been undertaken within the scoping for grant application and acceptance, in addition to adhering to any terms and conditions imposed by funding bodies. The Equalities Impact Screening Form has been appended to this report.

#### **7.0 CLIMATE CHANGE IMPLICATIONS**

- 7.1 There are no direct climate change implications arising from this report. Consideration for climate change issues have been undertaken within the scoping for grant application and acceptance, in addition to adhering to any terms and conditions imposed by funding bodies. The Climate Change Impact Assessment Form has been appended to this report.

#### **8.0 REASONS FOR RECOMMENDATIONS**

- 8.1 Reputationally, participation in the SLIP Programme as a Lead Partner has resulted in extremely positive feedback by DfE colleagues, who see NYC as a credible and trustworthy partners.
- 8.2 Financially, participation has enabled NYC to use any variance in funding to secure

additional resource capacity and training, to support internal improvements, and this would be expected to continue if able to participate through 2024/2025.

- 8.3 The additional SFPC legacy funding being made available by the DfE, under SLIP, is directly related to the impact of the NYC 'No Wrong Door' model being adopted and adapted in other LA areas across the country. As a result, the DfE have assigned this extra funding to provide the opportunity to continue the legacy of this Programme.

## **9.0 RECOMMENDATIONS**

- 9.1 The Executive Member for Children and Families in consultation with the Chief Finance Officer and the Executive Member for Finance authorises the acceptance of grant funding of up to £500,000 from the DfE under the Sector Led Improvement Partner Programme.

NYC are a confirmed DfE lead partner who would provide support to eligible local authorities who require support to improve their children's services.  NYC will work with other LAs to understand what priority areas they want to improve in their own authority and to scope work accordingly to help them to move toward understanding the changes they would want to take forward. This will be undertaken via meetings (mostly online with occasional face to face/site visits if this was the only way to facilitate a session).
<b>Why are you proposing this? What are the desired outcomes?</b>	The desired outcome is to successfully apply for approval to accept an increased amount of grant funding (up to £500k during 2024/2025) to cover the required programme costs and ensure NYC can deliver the programme with no financial detriment.

<b>Brief description of proposal</b>	<p>To seek approval to accept grant funding from the Department for Education (DfE) to participate in, and to cover the associated programme costs of, the DfE's Sector Led Improvement Programme (SLIP) 2024-2025. NYC have been selected again as a DfE SLIP Lead authority under the new SLIP programme for 2024/2025, which is a programme set up to provide short packages of advice and support from Good our Outstanding LAs into LAs who require support to improve their children's services.</p> <p>NYC are approved to be part of the next Programme and NYC will work with eligible LAs to understand and scope priority areas they want to improve in their own authority. NYC will then work to develop a joint plan with agreed activities and meetings required to support them to achieve this.</p> <p>This work will be undertaken via meetings with individual LA colleagues of which the vast majority of are online (over 90% for the current programme) with occasional face to face/site visits if work cannot be undertaken virtually. At the point of starting the Programme NYC do not know which LAs will be eligible and therefore it is not known who we would be working with, to reasonably estimate any impact on travel arrangements. However, as noted, the main option is to seek virtual sessions, and minimise any need for travel by car or by public transport.</p> <p>This Impact Assessment is to accompany an application to seek approval to apply for additional grant funding under the SLIP Programme for 2024/2025.</p>
