Statutory Licensing Sub-Committee

Procedure

Introduction

- 1. The Sub-Committee will conduct its hearings fairly, observing the basic rules of natural justice.
- 2. Each hearing will take the form of a discussion led by the Chair and cross examination will not be permitted unless the Sub-Committee considers that cross examination is necessary.
- 3. Hearings will be held in public but the Sub-Committee may decide to exclude the public from all or part of a hearing where it considers the public interest in doing so outweighs the public interest in the hearing taking place in public. In this context "public" includes any party to the hearing or any representative of a party.

Procedure

- 4. At the beginning of the meeting the Chair shall:
 - a) ask those present to introduce themselves;
 - b) explain the procedure;
 - c) ask the parties whether they wish permission for another person to appear at the hearing.
- 5. The Sub-Committee will consider requests from the parties for permission for other persons to appear at the meeting. Such permission will not be unreasonably withheld.
- 6. The Chair will conduct the hearing taking representations from the parties in the following order:
 - a) the Licensing Officer who will outline the background to the case. The Licensing Officer's role is to provide factual information to the Sub-Committee.
 - b) the applicant/licence holder (including any person appointed to represent the party or any other persons who have been given permission to assist the party).
 - c) any party making representations (including any person appointed to represent the party or any persons who have been given permission to assist the party).



- 7. Before determination, the applicant/licence holder will be given the final opportunity to address the Sub-Committee.
- 8. Each party will be given an equal maximum period of time in which to put forward any additional information requested by the Council, to question other persons (if given permission by the Sub-Committee) and address the Sub-Committee.
- 9. The Sub-Committee may exclude disruptive persons in certain circumstances.
- 10. The Sub-Committee may adjourn the hearing in certain circumstances.
- 11. The Sub-Committee will ask the parties to withdraw so that it can consider its determination. In considering its determination, the Sub-Committee may ask its Legal Advisor to provide it with legal and procedural advice. The nature of this advice will be notified to the parties.
- 12. The Sub-Committee will make its determination at the end of the meeting and this will be confirmed in writing.

Failure of Parties to Attend a Hearing

- 13. If a party has informed the Council that they do not intend to attend or be represented at a hearing, the hearing may proceed in their absence.
- 14. Where a party has not so indicated fails to attend or be represented at a hearing the Sub-Committee may:
 - a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date; or
 - b) hold the hearing in the party's absence.
- 15. Where the hearing is held in the absence of a party, the authority shall consider at the hearing of the application, representation or notice made by that party.
- 16. Where a hearing is adjourned to a specified date the Council will notify the parties of the date, time and place to which the hearing has been adjourned.

Application for the Variation of a Premises Licence for the Duke of York, 124 Church Street, Whitby, YO22 4DE.

Report of the Corporate Director – Environment

1.0 PURPOSE OF REPORT

1.1 To seek the determination by the Statutory Licensing Sub-Committee of an application for the Variation of a Premise Licence (Licensing Act 2003 'The Act')

2.0 SUMMARY

- 2.1 An application for the variation of a premise licence has been received from Stonegate Pub Company Limited and is attached at **Appendix A.** A copy of the existing premises licence (PL0431) is also attached at **Appendix B.**
- 2.2 The application seeks to vary the layout of the premises to include the basement bar servery within the licensed area which will be used to serve the adjacent external seating area as indicated on the plan. The application also seeks to add additional conditions relating to the management of the bar servery area which are outlined at 3.2 of the report. These conditions would restrict the use of basement bar servery to between 10:00 and 22:00 each day.

3.0 **Promotion of Licensing Objectives**

- 3.1 Section 4 of 'the Act' places a duty on the Licensing Authority to carry out its functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of public nuisance
 - The protection of children from harm
- 3.2 The following conditions have been offered as part of the application:
 - The operation of the basement servery shall be limited to between 10:00 and 22:00 hours each day.
 - Whilst the basement bar servery is operating appropriate staff will be deployed for the purposes of floor walking to monitor the external area.
 - At all times the basement bar servery is in operation there should be a minimum of one member of staff on duty at the bar linked to the premises radio/ contact system.

• The premises will implement an external area management plan for use when the basement bar servery is in operation.

4.0 Representations

- 4.1 A relevant representation has been received from a member of the public and is attached at **Appendix C**, the representation is in line with the following licensing objectives:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of public nuisance
- 4.2 The representation is summarised as follows:
 - That the service of food and drink between 10:00 and 22:00 will disturb the residents of a nearby property which has bedrooms overlooking the area.
 - That the variation may lead to an increase in drunken and anti-social behaviour in an area frequented by families.
 - That the variation may lead to the peaceful tranquillity being ruined by loud, drunken, and obnoxious individuals.
 - That there is no safety barrier in place around the external area which may lead to drunken individuals falling into the water.
 - That customers leaving the premises may disturb nearby residents.
- 4.3 Members should note that some of the grounds for the representations may not directly relate to the licensing objectives but have been included in the interests of openness and transparency.

5.0 ALTERNATIVE OPTIONS CONSIDERED

5.1 All of the Sub-Committee's options are outlined at 12.0 of the report. No alternative options are available.

6.0 FINANCIAL IMPLICATIONS

6.1 The costs involved in administering the Licensing Act 2003 are set in statutory legislation.

7.0 LEGAL IMPLICATIONS

- 7.1 As a relevant representation has been received, the Sub-Committee must hold a hearing to consider the representation and, having regard to the representation, determine the application.
- 7.2 The Sub-Committee must have regard to the promotion of the four licensing objectives in exercising its functions under the Licensing Act 2003.
- 7.3 The Sub-Committee must also have regard to the statutory guidance under section 182 of the Act and the council's own statement of licensing policy exercising its functions under the Act.
- 7.4 The applicant and all parties to the hearing may appeal against the decision of the Licensing Sub-Committee. Appeals must be made to a Magistrates' Court within 21 days of receiving notification of the decision.

8.0 CLIMATE CHANGE IMPLICATIONS

8.1 No climate change implications have been identified.

9.0 POLICY IMPLICATIONS

9.1 The following sections of the Scarborough Locality Statement of Licensing Policy are relevant in considering the licensing objectives:

"3.8 The Council has a duty under Article 8 of the European Convention on Human Rights to protect the rights of its residents to privacy and family life. The Council also acknowledges the rights of businesses in its area to operate, but this must be balanced against the rights of residents not to be disturbed by unreasonable noise and nuisance caused by licensed premises".

"3.9 It is acknowledged that the Council has a duty to exercise its functions with a due regard to the likely effect of the exercise of those functions on, and the need to do all that it can to prevent, crime and disorder in its area. In addition we will seek to support strategies where they are allied to the licensing objectives".

"3.10 The licensing authority is unable to refuse or impose conditions on valid applications where no relevant representations have been made. Where conditions are imposed, they shall be appropriate and proportionate and shall be tailored to the size, style, characteristics and activities that take place at the premises concerned".

"3.11 In addition conditions imposed shall be precise and enforceable, clear in what they intend to achieve, shall not duplicate other statutory requirements or other duties or responsibilities placed on the employer by other legislation, shall not replicate offences set out in the 2003 Act or other legislation, shall be justifiable and capable of being met and shall not seek to manage the behaviour of customers once they are beyond the direct management of the licence/certificate holder and their staff".

- 9.2 The Sub-Committee should also consider the following sections of the S182 Licensing Act 2003 Guidance:
 - Principles 1.15 to 1.17
 - Crime and disorder 2.1 to 2.7
 - Public safety 2.8 to 2.20
 - Public nuisance 2.21 to 2.27
 - Beer gardens or other outdoor spaces 8.35 to 8.37
 - Advertising applications 8.80
 - Conditions 10.1 to 10.10

10.0 EQUALITIES IMPLICATIONS

10.1 No equalities implications have been identified for this matter.

11.0 REASONS FOR RECOMMENDATIONS

- 11.1 In accordance with section 35 of the Licensing Act 2003, the licensing authority must hold a hearing to consider the application and any relevant representations.
- 11.2 The Sub-Committee must, having had regard to the application and any relevant representations, take such steps (if any) as it considers appropriate for the promotion of the licensing objectives.

12.0 RECOMMENDATION(S)

The Licensing Committee has the following options:

- i) To modify the conditions of the licence; or
- ii) To reject the whole of part of the application.

And for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

In making its decision, the Sub-Committee must act with a view to promoting the licensing objectives. The Sub-Committee must also have regard to its Statement of Licensing Policy and the Statutory Guidance issued under Section 182 of the Act.



We have considered the impact of the proposed variation which seeks to vary the layout of the premises to show the basement and license a bar servery within the basement which will be used to service the external area. We are not seeking any extension to permitted hours for licensable activities or opening hours.

The external area is owned by the council and permission for the applicant to use it is by way of a separate licence including the placing of tables and chairs for customer use and consumption of food and drink including alcohol within the area.

Steps have been taken to ensure that the application and proposed operation will continue to promote the licensing objectives, and in particular we have undertaken consultation regarding the licensing of the basement servery with the Licensing Authority Officer prior to submission and pre application consultation comments have been taken into account in considering and submitting this application.

Furthermore, conditions have been offered *within the application* as *measures to ensure continued promotion of the licensing objectives:*

- The operation of the basement servery shall be limited to between 10:00 and 22:00 hours each day.
- Whilst the basement bar servery is operating appropriate staff will be deployed for the purposes of floor walking to monitor the external area.
- At all times the basement bar servery is in operation there should be a minimum of one member of staff on duty at the bar linked to the premises radio/ contact system.
- The premises will implement an external area management plan for use when the basement bar servery is in operation.

Given the basement bar servery will be manned at all times it is in operation this will further assist in monitoring the existing external area alongside CCTV in place that covers the external area. Also, capacity via maximum number of covers is already limited under the licence permission granted by the council for use of the external area.

The applicant can further assure you that it has extensive experience in operating such external seating areas across the country, in many areas, in close proximity to residents and are committed to working in partnership with their local community. The applicant has management policies in place adapted at site level as appropriate which assist in managing nuisance in such external areas and monitoring customer behavior.

If the application is granted the existing licence conditions, policies and internal measures in place will continue to apply, including training staff to sell alcohol responsibly and in accordance with licensing law, alongside the additional condition as to restricting use of the basement servery, as a result, it is submitted that variation is unlikely to add to issues in the area or undermine the promotion of the licensing objectives.






BASEMENT FLOOR PLAN SCALE 1:50

ANNEX 1 - MANDATORY CONDITIONS

MANDATORY CONDITIONS APPLICABLE TO ALL PREMISES LICENCES UNDER THE LICENSING ACT 2003.

Requirement for a Designated Premises Supervisor

- 1. No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of films

- 1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.
- 3. Where
 - (a) The film classification body is not specified in the licence, or
 - (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, admission of children must be restricted in accordance with any recommendation made by that licensing authority.
- 4. In this section "children" means any person aged under 18; and "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c39) (authority to determine suitability of video works for classification)

Door Supervisors and Security Staff to be licensed by the SIA

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority, with the following exceptions:
 - (a) Premises where the premises licence authorises plays or films.
 - (b) Any occasion mentioned in paragraph 8(3)(b) or (c) of Schedule 2 to the Private Security Industry Act 2001 (premises being used exclusively by a club premises certificate, under a temporary event notice authorising plays or films under a gaming licence), or
 - (c) Any occasion within paragraph 8(3)(d) of Schedule 2 to the Private Security Industry Act 2001.

Age verification policy

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:

- (a) a holographic mark, or
- (b) an ultraviolet feature.

Minimum price of alcohol

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula -

 $P = D + (D \times V)$

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) the holder of the premises licence.
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The following conditions apply where the licence or certificate authorises "on" or "on and off" sales

No irresponsible drinks promotions

- 1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the

- premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free water

1. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Small measures to be available

- 1. The responsible person must ensure that;
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - (i) beer or cider: $\frac{1}{2}$ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

General


- 1. There shall be a 30 minute 'wind down' period after the permitted hours for the sale of alcohol.
- 2. Live Music shall be no more than 2 days per week. These days shall vary. The live music shall be by way of a single person with amplified voice/instrument.
- 3. Recorded Music shall be by way of music playing unobtrusively in the background.
- 4. The licensee shall request taxis to be considerate when picking up fares from outside of the premises and specifically request them not to sound their horns.

<u>CCTV</u>

- 5. The following CCTV conditions shall apply to this licensing application
 - i) A colour digital CCTV system shall be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises.



Letter of Objection to the Notice of application to vary a Premises Licence under Section 34 of the Licensing Act 2003

I am writing this letter with reference to the above application that has been requested by Stonegate Pub Company Limited for a proposed variation of change of use to the Duke of York in Whitby. This notice is hardly visible due to it being printed on blue paper making it very difficult for people to read.

I would like to object most strongly to the proposed changes as my property is situated next door literally just a few yards from where they propose to serve food and drink from 1000 hrs to 2200 hrs with two of my bedrooms overlooking the area and one of these rooms being where the baby sleeps and she is put down at 1900 hrs.

Whitby is becoming renowned for people holding their stag or hen parties, they are overly loud, rude, abusive and the language is obscene and absolutely disgusting. Because this area is situated next to a very popular beach that in the warm months is full of families enjoying themselves with their children and antics of drunken groups in close proximity is not something that should have to be tolerated by people wanting to enjoy themselves with their families.

The area that they are proposing to use has always been used by the public to sit and enjoy the view out to sea and families who have been on the beach get their children organised here before they go home, it is most certainly not suitable for an area where people can eat and drink and get drunk due to the fact that there are no safety barriers that would give protection to people in a drunken inebriated state from falling into the water.

There are no guarantees that this is not going to become a problem and supposed bouncers are not as effective as they should be even now people find a way to come out of the pub with their drinks that are not permitted outside.
