1 Purpose of Report

1.1 To invite the Panel to consider its future work programme.

- 3 Additionally, in view of the forthcoming County Council election on 5th May 2022, guidance has been sought from the NYCC Monitoring Officer regarding the Panel meeting due to be held during this period on 28th April 2022. As this meeting would fall within the formal pre-election period, and as councillor activities are restricted during this time, it has been recommended that the Panel re-schedules its April meeting to a date outside of the pre-election period.
- 4 Arrangements will therefore be made for an alternative meeting date to be scheduled – in place of 28th April – for sometime in early/mid-March 2022. This will be confirmed with the Commissioner's office and Panel members shortly.
- 5 Members are also invited to provide further suggestions for the work programme.
