Work Programme

1 Purpose of Report

- 1.1 To invite the Panel to consider options for its future work programme.
- The Panel is responsible for setting its own work programme taking into account the tasks that the Panel must undertake and the priorities defined by the Commissioner within the context of the Police and Crime Plan and Fire and Rescue Plan 2022/25.
- The Panel has expressed the view that it would like to consider whether there would be benefit in taking a slightly different approach to its work programme; identifying if there's a way which could facilitate scrutiny by focussing agendas around progress against key principles and priorities from the Commissioner's two Plans. There are potentially two workable approaches to consider for the forward programme, as outlined below.
- 4 Option 1 Continue with the current blend of statutory items and topics of interest taken across the year

At present, alongside the statutory items which must be taken at certain points in the year (e.g. precept in February, Annual Reports in July, etc), the Panel has broadly speaking a work programme based around identified key areas of scrutiny interest over the last few years. A number of these, such as review of Force Control Room performance and hate crime, are taken as annual update reports. Appendix A highlights the current work programme for reference. The Panel can choose to continue on this basis. A benefit to this approach is that it is very malleable and a range of topics related to areas of focus from the two Plans can be reviewed at any given meeting. A potential disbenefit though is that it is perhaps more difficult for Members to feel that they are able to take a focussed view around performance as updates around themes are more scattered across the year.

5 Option 2 – Adapt the work programme to align with the Commissioner's four CARE principles

The Commissioner's two Plans share four similar **CARE principles**, which set out what the Commissioner believes is an exemplary fire and rescue and police service and which must be embedded in all that the services do over the next two to three years. These are:

Caring about the vulnerable

 Includes:- (NYP) Making all women and girls safer; Embed compassion for victims and the vulnerable; Prevent harm before it happens; Tackle hidden harms. (FRS) Prevent harm and damage before it happens; Enhance our role in achieving wider public safety; Embed compassion for the vulnerable.

Ambitious collaboration

 Includes:- (NYP and FRS) Enhance collaboration; Take a whole system approach to tackling core problems.

Realising our potential

 Includes:- Maximise funding to improve our services; Properly skill and equip our people; (NYP only) Improve trust and confidence in our police; Develop our people and organisation to meet our communities' needs; (FRS only) Build a diverse and inclusive workforce.

• Enhancing our service for the public

- Includes:- Embed a customer and community focus; Promote a more visible presence in communities.
- One approach may therefore be for Panel to review performance thematically in terms of the CARE principles; taking perhaps a couple of reports relating to one principle at each Panel meeting. This would sit alongside any additional statutory items (review of Annual Reports, confirmation hearings etc) and of course any ad-hoc or reactive scrutiny items needed. Appendix B illustrates how this may work in practise. A clear benefit to this approach would be that on at least an annual basis, there would be opportunity for the Panel to focus in more exclusively on a key area of performance from the two Plans. It should be noted that it wouldn't be possible to cover all aspects of a given principle and Members would need to identify those areas they wanted information on.
- The above and appendices are initial drafts and would require further thought and co-planning with the OPFCC before any change in approach is agreed. However, the Panel are invited to consider adapting to Option 2, with perhaps a review point built in for a year's time.

8 Recommendations

8.1 That the Panel considers adapting its work programme to align more closely with scrutiny of the Commissioner's key CARE principles.
