Update on the Highways Capital Programme

Report of the Assistant Director – Highways and Transportation

1.0 Purpose of Report

- 1.1 To seek agreement from the Corporate Director Business and Environmental Services (BES), in consultation with the Executive Member for Highways and Transportation, to add new schemes to the Highways Capital Forward Programme (HCFP) and the 23/24 highways capital annual programme
- 1.2 To update the Corporate Director BES and the Executive Member for Highways and Transportation on the following
 - i. Delivery of the 22/23 Highways Capital Annual Programme including schemes that have been moved into future year's annual programme
 - ii. Impact of cost increases and inflation on the Highways Capital Programme
 - iii. Schemes to be included within the 23/24 Highways Capital annual Programme

2.0 Background

- 2.1 The Highways Capital Programme (HCP) is made up of Street Lighting, Bridges and Structures, Integrated Transport and Structural Highway Maintenance. They are each subject to their own prioritisation methods based upon an assessment of the problem that is being addressed.
- 2.2 The Corporate Director BES in consultation with the Executive Member for Highways and Transportation considered a report on 27 May 2022 where the provisional headline allocations and distribution of the 2023/24 budget for the various works categories were agreed. These headline allocations are based on an indicative funding settlement of £40.7M from the Department of Transport (DfT) and is the same as funding received for the current financial year. We are aware that as long as the allocation remains 'indicative' it could still be subject to change, and we are awaiting further updates.
- 2.3 A further report was presented on the 26 August 2022 to approve the addition of schemes in to the HCFP

3.0 Delivery of the 22/23 Annual Highways Capital Programme

3.1 Delivery of the 22/23 HCP is well underway, with a significant proportion of schemes either completed or in progress. There remains some works to start on site, however, plans for these are well advanced. At present we estimate that by the end of Q3, 94% of the total LTP budget will either have been spent or have a firmed-up delivery date for delivery in the remainder of the financial year. The remaining programme value is accounted for by schemes awaiting confirmed on site start dates and are still expected to be completed this financial year.

- 3.2 At present we estimate that we are in the region of £4.4M over programmed for 22/23. Included within the over programming figure is an allowance for price increases linked to inflation for schemes still to be delivered on site. As final costs are confirmed for these schemes, we will update the proposed costs to understand how these impact on over programming. Typically, we seek to have a level of over programming in the region of 10% within the capital programme to allow some level of flexibility to take in to account potential scheme delays for example and so it is expected that this over programmed figure will reduce by year end as described in paragraph 3.4 below.
- 3.3 It is important to note that any over programming in 22/23 will be funded from the 23/24 budgets. This is accounted for as part of the available funding for 23/24.
- 3.4 As part of the programme management process we rank schemes based on their risk of non-delivery within the annual programme. At present there is £250K of schemes ranked as amber (50% chance of non-delivery) and £1.9M ranked as red (75% chance of non-delivery). As scheme delivery dates are confirmed with contractors, this information is updated, with schemes either being delivered or deferred in to 23/24. The high risk of delayed delivery of the red risk schemes is one of the reasons for the high over programming figure. If the red risk schemes are not delivered this financial year, then over programming would be in the region of £2.5M.
- 3.5 Some schemes have been brought forward from the HCFP in to 22/23 to replace schemes that have been deferred into future years due to issues with delivery on site. Appendix A lists the new schemes brought forward in to the 22/23 annual programme.
- 3.6 Additionally, some schemes have moved from the 22/23 annual programme into future years. It is the intention that, wherever possible, schemes moved from 22/23 are included within the 23/24 annual programme. In total £5.6M of highway schemes have been deferred and a further £3.6M of Bridges schemes. These cost estimates include an allowance for inflation. Appendix B provides a full list of schemes that we are proposing to defer. Funding for the delivery of these schemes will be from the annual budget of the year that they are delivered in, eg schemes moved from 22/23 in to 23/24 will be funded from the 23/24 budget.

4.0 23/24 Annual Programme

4.1 Using the indicative £40.7M funding settlement from DfT, the following table provides an overview of the sources of funding and how funding is allocated in 23/24. This takes into consideration the 22/23 over programming figure and the movement of deferred schemes from 22/23 in to 23/24.

- 4.2 At present we are proposing that we will be over programmed by £7.27M going in to 2023/24. A significant proportion of this level of over programming relates to an inflation allowance that we have applied to all schemes within the HCFP. The allowance selected was based on feedback from NYH and a review of available indices during August this year.
- 4.3 Given recent changes to construction inflation indices (there has been a downward trend), we are aware that this allowance may be higher than the actual increase we will see on scheme costs. We will monitor tender submissions submitted from the NYH supply chain for 23/24 works packages and adjust the annual programme accordingly.
- 4.4 Where scheme costs come in lower than the 23/24 annual programme value, this "saving" will be used to offset the over programming value and if feasible bring in further schemes from the HCFP.
- 4.5 We have already identified potential schemes from the HCFP that could be brought in to the 23/24 annual programme should the financial position permit this. We are also working with NYH to identify further surface dressing schemes that could be added to the 23/24 capital programme.

5.0 Schemes for addition to the Forward Programme

- 5.1 Appendix C provides information on schemes we are seeking to add to the forward programme. These schemes have been identified since August 2022 and predominantly consist of patching and surface dressing schemes, the bulk of which we are seeking to deliver in 23/24.
- 5.2 One of the schemes that we are adding to the HCFP, is a bridge maintenance scheme on the A19 at Eggbrough Canal. A recent bridge inspection has identified an issue with the bridge deck waterproofing which is causing issues to the road surface. We are seeking to bring this scheme in to the 22/23 annual programme with delivery planned imminently subject to approval at this meeting.
- 5.3 In Area 3 (Scarborough Area), three of the schemes that we are adding to the HCFP are intended for delivery as soon as possible, with design and development work already underway. They are as follows;
 - Hunters Sty Landslip scheme near Westerdale
 - Stonebeckgate Lane drainage scheme near Fryup
 - A169 / A171 roundabout drainage near Whitby

- 5.4 Schemes are added to the forward programme using data collected from asset condition surveys alongside consideration of sites identified by operational teams as requiring future maintenance activity.
- 5.5 We are proposing to add a further 54 schemes to the total value of £1.2M to the HCFP.
- 5.6 As outlined at the August 2022 BES Executive members meeting, for the purposes of budget and programme management, surface dressing and patching schemes within the annual programme will be combined into area specific budget lines based on network hierarchy and treatment type.

6.0 Schemes within the 23/24 Capital Programme

- 6.1 Appendices D-K outline schemes proposed for delivery in 23/24 as part of the annual capital programme. An update on 23/24 Street Lighting schemes will be provided at a future meeting.
- 6.2 Asset condition information alongside local engineering input is used to determine which schemes on the HCFP are selected for delivery. We select schemes up to available budgets.
- 6.3 Given the reduced amount of funding available for new schemes due to inflation, over programming and schemes deferred from 22/23, the number of schemes that we are delivering in 23/24 has reduced compared to previous years. The allocation for some scheme types such as footway Resurfacing and Reconstruction are significantly reduced, with scheme delivery now planned for 24/25.
- 6.4 Ahead of scheme delivery in 23/24, officers alongside our design and delivery partners WSP, APP and NYH, are reviewing scheme designs to identify any potential efficiency savings, through using alternative treatments, changing scope and scale. This process is currently ongoing and will continue throughout the remainder of Q3 and Q4 of 22/23.

7.0 Financial Implications

- 7.1 Sections 3 and 5 of this report provide an overview of financial implications. We carry out continuous monitoring of programme delivery and scheme costs to ensure that appropriate decisions are made in respect of programme management ie ensuring we spend within budget limits and schemes are moved between programmes to match available funding.
- 7.2 Officers will develop proposals on how to manage the cash flow implication over year-end to manage any over programme. This is to manage the period between year end and the receipt of the 23/24 LTP grant from DfT.
- 7.3 The contents of this report make no change to the BES Capital Plan expenditure limits.

8.0 Equalities Implications

8.1 Consideration has been given to the potential for any adverse equality impacts arising from the recommendation. An Initial equality impact assessment screening form has been carried out see Appendix L. The allocation of funding is based on the "manage, maintain and improve" (MMI) hierarchy set out in Local Transport Plan 4, which has been the subject of an Equality Impact Assessment (EIA). This concluded

that the introduction of fewer improvement schemes may have a greater impact on people with mobility difficulties or without access to a private vehicle as there will be fewer new facilities provided e.g. pedestrian crossings, dropped kerbs, bus stop accessibility improvements; however, it is also considered that prioritising maintenance, particularly for footways, through the MMI hierarchy is likely to produce a net benefit for people with the same protected characteristics; particularly in terms of age and disability.

8.2 Furthermore, the local accessibility budget has been agreed and introduced. This has achieved a positive equality impact as it provides flexibility for funding for improvement schemes such as dropped kerbs which reduces the impact that the MMI process has on people with mobility difficulties or those without access to private vehicles. This also ensures the recommendation does not have an adverse impact on any of the protected characteristics identified in the Equalities Act 2010. Taking into account the local accessibility budget and the positive outcome of the EIA in the Local Transport Plan 4. With regards to the MMI hierarchy it is considered that there are no adverse impacts arising from the allocation of funding based on the MMI and subsequent recommendation. Therefore, an Equalities Impact Assessment is not required. The Authority will continue to consider and pay due regard to the Public Sector Equality Duty throughout the allocation of funding for the Capital Programme.

9.0 Legal Implications

- 9.1 The County Council as Local Highway Authority has a wide range of statutory duties imposed by a variety of legislation relating to highways and transportation and also has a wide range of duties imposed by legislation in its capacity as Lead Local Flood Authority, Street Authority and Local Traffic Authority. This includes a duty under S41 of the Highways Act 1980 to maintain highways maintainable at the public expense and a duty under S122 of the Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. Under S16 of the Traffic Management Act 2004, the County Council is also required to manage its road network to secure the expeditious movement of traffic in that network.
- 9.2 The forward programme and associated annual programmes have been developed and prioritised in line with the County Councils duties and responsibilities under the above and other legislation, including the Transport Act 2000 and the Flood and Water Management Act 2010.

10.0 Climate Change Impact

10.1 A climate change impact assessment has been carried out, see Appendix M. This identifies that the development of a forward programme will help to improve efficiency of delivery, reducing waste and emissions through improved coordination and planning of works.

10.0 Recommendations

- 10.1 It is recommended that the Corporate Director Business and Environmental Services, in consultation with the Executive Member for Highways and Transportation:
 - approve the schemes listed in Appendix C for inclusion within the Highways Capital Forward Programme

- ii. approve the schemes to be added to the 23/24 annual programme
- iii. Note the updates on the following
 - a. 22/23 annual programme
 - b. Impact of costs increases and inflation
