## 3.0 TREASURY MANAGEMENT

3.1 The Bank of England have continued to increase interest rates, with rates increased from 4.0% in February, 4.25% in March and to 4.50% in May.

Following these interest rate rises, the County Council's Treasury Advisors, Link, revised their own Interest Rate forecasts on 25 May 2023. It is now forecast that further increases will be made throughout the rest of the financial year, peaking at 5.00% in September 2023 (previously 4.50% in June 2023) when rates are then expected to gradually fall to 2.5% by September 2025.
