# APPENDIX F

6 The use hereby permitted shall only operate between the following hours:

Monday to Saturdays 12.00 noon to 23.00 Sundays and Bank Holidays 12.00 noon until 21.00 Christmas Eve 12.00 noon until 01.00 am New Year's Eve 12.00 noon until 01.00 am.

The premises shall be closed to customers outside of these hours.

Reason: To limit the potential for noise generation and to prevent nuisance arising in order to safeguard amenity of the occupiers of surrounding residential properties in accordance with Policy ENV3 of Craven Local Plan and paragraph 180 of the National Planning Policy Framework.

There are no issues with the proposed opening times or sale of alcohol hours below for Monday to Saturday. However, the planning approval only allows for the premises to be open until 21:00 on Sundays and Bank Holidays, therefore the final sale of alcohol must be 20:45.
