NYC CYPS BRIEFING PAPER – JUNE 2023

For Members of Skipton and Ripon Area Constituency Committee SKIPTON TOWN PRIMARY SCHOOL PLACES

1. BACKGROUND

- 1.1. During the consultation on the draft Craven Local Plan the need for additional primary school places within Skipton Town was identified. Two new sites for primary school provision of 210 places each were requested. It was suggested that one of these could be located on land already within (then) NYCC's ownership to the north west of the town (Raikeswood Drive), and the other could be within sites SK088, SK089 and SK090 (Airedale Ave and Elsey Croft). Given the timescales around the housing developments on these two sites it was agreed that CYPS would, as a proposed alternative to a new school at Airedale Avenue and Elsey Croft, pursue an expansion of an existing school in Skipton to maintain school place sufficiency.
- 1.2. The project identified to be taken forward is to expand Greatwood Academy by one form of entry. A delivery timetable was established which would see the additional places available from September 2024. Following detailed design work planning approval was secured. A procurement exercise was then undertaken earlier this year which resulted in a lowest tender figure that was significantly higher than the pretender estimate, and considered to be uneconomical.
- 1.3. The project cost position led to a review of pupil forecasts which showed that additional places were no longer essential for September 2024. The subsequent decision to delay the scheme provides opportunity to re-evaluate the need for additional places, and if required, re-tender using a different procurement route to be better placed to achieve value for money.

2. TOTAL SCHOOL ROLLS

2.1 The table below shows the total number of pupils on roll in Reception to Year 6 at each town primary school since 2014. There is perhaps a locally held view that numbers have been increasing over time. However, as the data shows the numbers peaked in 2017 and have fallen since that time. This is despite the housing growth in the last 5 years and reflects that any impacts of new housing have not compensated for an underlying demographic which has been on a downward trend.

3. 2023 ADMISSIONS ROUND

3.1 This most recent allocations round (April 2023) for entry to Reception in September 2023 is showing a significant fall in pupil numbers.

The table below shows the number of reception age pupils admitted each September. This shows a reduction across all schools for 2023 compared to the last few years, and reflects unexpected levels of under-subscription.

3.2 The Council now has access to data via the NHS of the numbers and age of children at each postcode who are registered with a local GP. This assists in establishing the numbers of local children in each age group cohort and is particularly helpful for the pre-school age groups.

Although the NHS GP registration data for 2023/24 did not show a spike it was expected that pupil yield from housing would be impacting on demand by now. This has not proved to be the case. Looking at the comparative data for the pre-school age children living in Skipton it is difficult to clearly state there will be a need for additional places in 2024 or 2025.

4. PUPIL FORECASTS

The pupil forecasts for Skipton Town primary schools have recently been updated following the April 2023 allocation of places described in section 3 above.

The table below shows the total forecast pupil numbers against the current available capacity across all primary schools in Skipton Town. It also shows the expected pupil yield from housing developments that have either already received planning permission or are included within the existing local plan.

The table therefore shows that the surplus capacity which exists in the Skipton town primary schools will be gradually eroded over time so that collectively they become increasingly 'full schools', but this happening depends upon the impacts of the expected new housing.

5. **HOUSING**

There are several housing developments currently being constructed in Skipton Town. The table below shows some of the larger developments that officers continue to monitor, with the number of units that have been completed, and also those that remain to be built. This is based on data received in March 2023. In addition to these sites there are numerous smaller developments of between one and six homes that are also being implemented. There are also a number of housing development sites within the existing Craven Local Plan that have yet to come forward.

6. GREATWOOD EXPANSION - CURRENT POSITION

In recognition of the uneconomical tender return, and in light of the pupil data shown above, it was determined by the Children and Young People's Service (CYPS) Leadership Team in April 2023 that the tender should be rejected, and therefore delivery of the one form expansion should be postponed until September 2026, subject to further review of pupil forecast data. The postponement has been discussed with Northern Star Academies Trust who are understanding of the reasons for delay.
