At present North Yorkshire Education Service (NYES) utilise and manage a NYC multi supplier framework for Schools Online Payments Systems. The framework has two lots, one which provides the systems and service via the NYES, an accredited service provide and lot two which provides the systems and service directly via the supplier. The framework is due to expire on the 31st March 2024.
