# Appointments to Committee According to Political Proportionality

# Report of Assistant Chief Executive, Legal and Democratic Services

#### 1.0 PURPOSE OF REPORT

1.1 To make recommendations for changes to the allocation of seats on and appointments to committees, subject to proportional representation due to recent political changes.

#### 2.0 BACKGROUND

- 2.1 A number of recent changes to the political make-up of the Council has had an effect on proportional representation.
- 2.2 These changes have occurred since the last Council meeting in July 2023.

#### 3.0 CHANGES SINCE THE LAST NORTH YORKSHIRE COUNCIL MEETING IN JULY 2023.

- 3.1 The changes to the political make-up of the Council that have occurred since the last Full Council Meeting due to 1 By-Election and changes of Elected Members political parties are as follows:
  - The Hutton Rudby and Osmotherley by election on 28 September 2023 went to the Conservative Party (Elected Councillor David Hugill). This brought no change to the overall political make up.
  - Tadcaster division in Selby and Ainsty changed from Unaffiliated Independents to North Yorkshire Independents in October 2023 (Councillor Kirsty Poskitt changed political group).
  - Harlow and St. Georges division in Harrogate and Knaresborough changed from Unaffiliated Independents to North Yorkshire Independents in October 2023 (Councillor Mike Schofield changed political group).
  - The resignation of Councillor David Whitfield leaves a vacant position in the Sowerby and Topcliffe division where a by election is due on 30 November 2023. This position was held by the Green party.
- 3.2 The number of Councillors by political group and party is now as shown below:

- 3.3 The changes outlined in 3.1 above have an impact upon the allocation of seats in Council committees under proportionality as it increases the proportionality of the North Yorkshire Independent Party from 1.42 (rounded to 1) to 1.78 (rounded to 2) on a 16 seat Committee.
- 3.4 This change has no impact on the proportionality of the Police Fire and Crime Panel.
- 3.5 The complete calculation is attached at Appendix A as well as the Area Constituency Planning Committee Allocation for Selby and Ainsty and Harrogate and Knaresborough at Appendix B, where changes have occurred. There are no changes to the proportionality of Richmond (Yorks) Area Constituency Planning Committee Allocation as the by election returned a Conservative position and Cllr Fortune was not appointed to this committee.
- 3.6 This change has no impact on the proportionality calculation of any of the appointments to Major Outside Bodies that are subject to political proportionality. This is detailed at Appendix C.

#### 4.0 ANALYSIS

- 4.1 The total impact of these changes can be found at appendix A to work out a purely mathematical proportionality basis for allocations. However, this calculation must comply with the principles found in paragraph 5.2 of this report.
- 4.2 The analysis suggests that allocation of seats on committees should be:

When considering 'Scrutiny and Audit' and by 'Ordinary' committees, the proportionality shows (see paras 5.3 and 5.4 for the definition of the committees):

- The Conservatives and Independents are over-represented by 3.47 seats on Scrutiny and Audit committees and over-represented by 2.33 seats on Ordinary committees (total over-representation of 5.80 seats).
   This is unable to be altered due to proportionality rule 2 when a Group has the majority of seats of a Council. (See 5.2 below)
- The North Yorkshire Independents are over-represented by 1.22 seats on Scrutiny and Audit committees and under-represented by 0.89 seats on Ordinary committees (total over-representation of 0.33 seats).
- Labour's figures are correct as per the mathematical proportionality calculation.
- The Liberal Democrats are under-represented by 1.31 seats on Scrutiny and Audit committees and over-represented by 0.56 seats on Ordinary committees (total underrepresentation of 1.87 seats).
- Unaffiliated Independents are under-represented by 3.53 seats on Scrutiny and Audit committees and under-represented by 0.67 seats on Ordinary committees (total under-representation of 4.20 seats).
- Green Group are over-represented by 1.29 seats on Scrutiny and Audit committees and over-represented by 0.44 seats on Ordinary committees (total over-representation of 1.73 seats).
- The result of the Sowerby and Topcliffe by election may further impact the proportionality.

The complete calculation is attached at Appendix A as well as the Area Constituency Planning Committee Allocation for Selby and Ainsty and Harrogate and Knaresborough at Appendix B, where changes in membership have occurred, and the calculations for Major Outside Bodies at Appendix C.

## 5.0 POLITICAL BALANCE GUIDANCE

- 5.1 The Local Government and Housing Act 1989 introduced a requirement that certain appointments should be proportionate to the political composition of the Council.
- 5.2 The Council or the Committee must give effect to principles set out in the statutory provisions. The principles are:
  - 1) All the seats must not be allocated to the same political group
  - 2) The majority of the seats must be allocated to the political group (if any) that holds the majority of seats on the Council
  - 3) Subject to 1) and 2), in the case of ordinary committees, the number of seats on the ordinary committees which are allocated to each political group must bear the same proportion to the total of all the seats on the ordinary committees as is borne by the number of members of that group to the membership of the Council.
- 5.3 Please note that "Ordinary Committees" of this Council are: Chief Officer Appointments and Disciplinary Committee; Employment Appeals Committee; Pension Fund Committee; Planning and Regulatory Functions Committee; (Transport) Appeals Committee and Standards Committee.
- 5.4 Scrutiny committees and Audit are not "ordinary committees".

- 5.5 This means that it is necessary to add up the total number of seats on all the ordinary committees. If a group represents, for example, three quarters of the membership of the Council, it is entitled to three quarters of the total number of seats on all ordinary committees.
- 5.6 This means that on some ordinary committees a group may have more members than the application of the next principle would justify. It provides an allowance for the fact that calculating the proportion will not usually lead to whole numbers.
- 5.7 The duty on the Council is to give effect to these principles so far as reasonably practicable. This recognises that there cannot be an exact application of the rules.
- 5.8 Co-optees are ignored in calculating political balance except for any co-opted member with voting rights appointed to a committee with education functions under section 13(5) Local Government and Housing Act 1989 see section 15 of that Act.

# 6.0 ADDITIONAL LOCAL CONSIDERATIONS

- 6.1 It is expected, although not required, that every Councillor, who is not on the Executive, has a place on either an Overview and Scrutiny committee or on the Audit Committee.
- 6.2 During the period of this Council it has been the practice to allocate 1 seat on Scrutiny and Audit committees and 1 seat on Ordinary Committees to each of the unaffiliated Independents. This is practice rather than a requirement.

## 7.0 RECOMMENDATION OF THE ALLOCATIONS COMMITTEE/GROUP LEADERS

- 7.1 In considering the proportionality calculations and analysis, it is recommended that the following changes be made to the allocation of seats on committees:
  - North Yorkshire Independents are currently down 1 seat on Care and Independence Committee and Independent Unaffiliated are 1 over (Cllr Tony Randerson)
  - North Yorkshire Independents are currently down 1 seat on Young Peoples Committee and Independent Unaffiliated are 1 over (Cllr Kirsty Poskitt already sits on this Committee)
  - North Yorkshire Independents are currently down 1 seat on Transition Committee and Independent Unaffiliated are 1 over (Cllr Kirsty Poskitt already sits on this Committee)
  - North Yorkshire Independents are currently down 1 seat on Corporate and Partnerships Committee Independent Unaffiliated are 1 over (Cllr Tony Randerson)
  - Scrutiny of Health is correct as there were already 2 North Yorkshire Independent Councillors on this Committee, although there is still currently 1 North Yorkshire Independent vacancy due to the resignation of Cllr Lindsay Burr.
  - North Yorkshire Independents are currently down 1 seat on TEEE Committee and Independent Unaffiliated are 1 over (Cllr Mike Jordan)
  - North Yorkshire Independents are currently down 1 seat on Strategic Planning Committee and Independent Unaffiliated are 1 over (Cllr Sam Cross)

## 8.0 ALTERNATIVE OPTIONS CONSIDERED

8.1 The Local Government and Housing Act 1989 introduced a requirement that certain appointments should be proportionate to the political composition of the Council and the Group need to consider a fair distribution of seats.

## 9.0 FINANCIAL IMPLICATIONS

9.1 There are no financial implications arising from this report.

## 13.0 REASONS FOR RECOMMENDATIONS

13.1 The Local Government and Housing Act 1989 introduced a requirement that certain appointments should be proportionate to the political composition of the Council. The changes to the political balance that resulted from the by-election and changes to political parties necessitated a review of the proportional allocation of seats.

# 14.0 RECOMMENDATION(S)

- 14.1 To bring to the attention of Council the following outcome and make recommendations for changes to the allocation of seats on and appointments to committees, subject to proportional representation.
- 14.2 The following changes are recommended:
  - 1 North Yorkshire Independent appointment is made to the Care and Independence Overview and Scrutiny Committee
  - Independent Unaffiliated give up a seat on Care and Independence Overview and Scrutiny Committee to North Yorkshire Independents
  - 1 North Yorkshire Independent appointment is made to the Corporate and Partnerships Overview and Scrutiny Committee
  - Independent Unaffiliated give up a seat on Corporate Partnerships Overview and Scrutiny Committee to North Yorkshire Independents
  - 1 North Yorkshire Independent appointment is made to the Transport, Economy, Environment and Enterprise Overview and Scrutiny Committee
  - Independent Unaffiliated give up a seat on the Transport, Economy, Environment and Enterprise Overview and Scrutiny to North Yorkshire Independents
  - 1 North Yorkshire Independent appointment is made to the Strategic Planning Committee
  - Independent Unaffiliated give up a seat on Strategic Planning to North Yorkshire Independents
  - 1 North Yorkshire Independent appointment is made to the Transition LGR
     Overview and Scrutiny Committee. Cllr Poskitt already sits on this Committee
  - Independent Unaffiliated lose their seat on Transition LGR Overview and Scrutiny Committee to North Yorkshire Independents
  - 1 North Yorkshire Independent appointment is made to the Children and Families Overview and Scrutiny Committee. Cllr Poskitt already sits on this Committee
  - Independent Unaffiliated lose their seat on Children & Families Overview and Scrutiny Committee to North Yorkshire Independents

- There is still a vacant North Yorkshire Independent seat on the Scrutiny of Health Committee awaiting a replacement nomination from the Group Leader. This is due to the resignation of Cllr. Lindsay Burr from this Committee.
- There is no change to the Harrogate and Knaresborough Area Constituency Planning Committee.
