## Committee places for the Overview & Scrutiny Committee and the Audit & Governance Committee

- 1. The Combined Authority (Overview and Scrutiny Committees, Access to Information and Audit Committees) Order 2017 (made under the powers contained within the Local Democracy, Economic Development and Construction Act 2009) provides that the Combined Authority must appoint to an Overview and Scrutiny Committee "so that the members of the committee taken as a whole reflect so far as reasonably practicable the balance of political parties for the time being prevailing among members of the constituent councils when taken together".
- 2. However it should be noted that Section 15 of the Local Government and Housing Act 1989 provides the duty of a relevant authority (including a Combined Authority) to allocate seats to political groups and Section 16 sets out the Authority's duty to give effect to allocations.
- 3. Therefore there is a question on whether to base political proportionality on political **groups** or political **parties**. Table 1 shows the basis of the calculation on political groups and Table 2 shows the basis on political parties. It is noted that a number of Combined Authorities use the latter methodology.

5. The constituent councils are asked to nominate six members each for the Overview and Scrutiny Committee and four members each for the Audit and Governance Committee. These nominations are to follow and to be approved by the Combined Authority.
