School organisation

- · 358 schools
- 208 are LA maintained schools (58%)
 - 3 Nursery (100%)
 - 181 Primary (61%)
 - 14 Secondary (33%)
 - 6 Special Schools (60%)
 - 4 Pupil Referral Units (80%)
- 150 are Academy schools (42%) in 32 Trusts



Ofsted Performance – as published 31 Jan 24

2 are LA maintained schools that are soon to convert to academies and will await re-inspection as an academy

Requires Improvement schools: 17 LA and 22 academies/non-maintained, 15 of these were judged RI since opening

Ofsted Performance — taking place and published since 1 Sept 2023

- 44 published state funded schools inspections in the period 1 Sept 23 to 31 Jan 24
 - 38 primary schools
 - 5 secondary schools
 - 1 special school / PRU
- 20 Section 8 ungraded inspections
 - 'School remains good'
- 24 Section 5 graded inspections
 - 1 Requires Improvement outcome, 22 'good' and 1 'outstanding'
- 98% of those inspected and published so far this academic year remain or became Good or Outstanding
