Executive Member Meeting 2nd July 2024 Young People's Pathway Report of the Corporate Director -Nic Harne and Stuart Carlton

1.0 PURPOSE OF REPORT

- 1.1 Agreement for proposals for Pathway 1- see Appendix A report which contains exempt information.
- 1.2 To agree the re commissioning of Pathway 2 for 2+1 years

2.0 BACKGROUND SUMMARY

Services are currently provided by other commissioned organisations as well as North Yorkshire Council. There are currently two distinct pathways for which NYC has responsibility for. These are known as Pathway 1 and Pathway 2.

Pathway 1 is the prevention arm of the service. Pathway 1 is an innovative approach to the prevention of homelessness prior to the entrance to statutory services for both CYPS and Housing. This allows the increased capacity for the prevention of youth homelessness through mediation, negotiation and individual bespoke wraparound support. This has been effective in reducing the need for provision of accommodation under Pathway 2 as shown in the data where Pathway 1 had a success rate in family reunification of 80% of young people in 22/23.

Pathway 2 is where accommodation is provided with support. The Pathway 2 offer is an accommodation offer to avoid the use of statutory services for vulnerable young people. Where Pathway 1 has not been successful, the young person is referred to a Hub Coordinator through the Housing Options teams across North Yorkshire. The Hub Coordinator assesses the situation to ensure that all preventative initiatives have been explored. This enables a coordinated approach across the council and an equitable service delivery.

The Pathway is a fundamental and crucial element of the Council's approach to meeting its wider statutory responsibilities under both children's and homelessness legislation. Effectively the Pathway alleviates the pressure on the Council's homelessness service through the provision of a bespoke and more cost-effective solution to meeting need than the statutory homelessness process. Any reductions in capacity within the Pathway are likely to be costly and have negative outcomes for young people overall, adding pressure and cost on the Council's homelessness service. As a result, more young people are likely to require assistance and the provision of temporary accommodation.

3.0 SUBSTANTIVE ISSUE

- 3.1 To reach a position to re procure Pathway 2 for the end of the current contract January 2025.
- 3.2 Agreement for proposals for Pathway 1see Appendix A which contains exempt information.

4.0 CONTRIBUTION TO COUNCIL PRIORITIES

4.1 To safeguard children, as well as supporting families in difficulty to ensure they receive help at the earliest opportunity and working with families to set clear outcomes to enable them to stay together.

Our Looked After Children's strategy sets out how we will deliver our duties as corporate parents. Where it is unsafe for a child to remain at home, we will provide safe, stable and secure permanence arrangements and ensure that children are well supported to leave the care system.

To deliver a successful transformation programme now and in the years to come, maximising the benefits of bringing eight councils into one to improve services for residents.

To help maintain housing supply, both market and affordable housing, whilst improving the quality of new homes.

To prevent and tackle homelessness

To help meet housing needs, including those of vulnerable households and those with specific needs.

To help ensure that people have a decent home to live in that facilitates their health and wellbeing

5.0 ALTERNATIVE OPTIONS CONSIDERED

A working group from both directorates has met over a period of months to formulate these proposals.

6.0 FINANCIAL IMPLICATIONS

A procurement process would be initiated.

7.0 LEGAL IMPLICATIONS

- 7.1 By agreeing the recommendations proposed CYPS and Housing services will be able to more efficiently meet their statutory responsibilities.
- 7.2 Meeting the contractual legal expectations through a procurement exercise for Pathway 2.

- ii) To agree the re-procurement of Pathway 2 for 2+1 years with a view for Housing to consider the wider Housing requirements under the housing strategy.
- For Funding of Pathway 2 to be shared on a 50/50 share between Housing and CYPS for the 2+1 recommissioning reflecting the demand for under 18 young people and over 18 young people.
