1.0 PURPOSE OF REPORT

1.1 To provide the Executive Member for Education and Skills with information upon which to make a decision to lower the age range of Scarborough Pupil Referral Unit from 11-16 to 5-16 from 31 August 2021.

2.0 EXECUTIVE SUMMARY

- 2.1 On 15 December the Executive Member for Education and Skills approved a public consultation on the proposal to lower the age range of Scarborough Pupil Referral Unit from 11-16 to 4-16 from 31 August 2021.
- 2.2 A consultation was carried out between 12 January and 23 February and this included a virtual public consultation meeting on 18 January carried out by the Children and Young People's Service.
- 2.3 Following further consideration of the proposal it is considered appropriate to amend the proposal to lower the age to 5-16. This aligns with the statutory duty that is to be met by the proposal.

3.0 BACKGROUND

- 3.1 Local authorities are responsible for arranging suitable full-time education for permanently excluded pupils, and for other pupils who because of illness or other reasons would not receive suitable education without such provision. This applies to all children of compulsory school age resident in the local authority area, whether or not they are on the roll of a school, and whatever type of school they attend. Full-time education for excluded pupils must begin no later than the sixth day of the exclusion.
- 3.2 Pupil Referral Units (PRUs) are a type of alternative provision which educate pupils who are unable to access mainstream schooling for any of the reasons set out above.
- 3.3 Although located in Scarborough town the PRU provides education to pupils from across the Scarborough District. The age range of the PRU is currently 11-16.

4.0 PROPOSAL

4.1 North Yorkshire County Council proposes:

To lower the age range of Scarborough Pupil Referral Unit from 11-16 to 5-16 with effect from 31 August 2021

5.0 CONSULTATION UNDERTAKEN AND RESPONSES

- 5.1 The consultation period ran from 12 January 2021 until 23 February 2021. A copy of the Consultation document is attached at Appendix 1.
- 5.2 Nine responses were received to the consultation; a copy of these are provided in Appendix 3. All nine responses were in support of the proposal. This included responses from the Scarborough PRU Management Committee, a parent of a pupil at the PRU and leaders of primary and secondary schools in the area.

6.0 ISSUES RAISED DURING THE CONSULTATION

6.1 <u>Funding of Provision</u>

At the virtual consultation meeting attendees asked for clarification about funding and how the change of age range would affect the Pupil Referral Unit financially. A written response also commented how important it was that the funding of the provision was in place to pay for additional qualified staff. Officers confirmed that the Local Authority was directly supporting the specific costs of the primary provision so that overall the Pupil Referral Unit would not be financially disadvantaged.

6.2 <u>Review of Provision</u>

Another attendee at the consultation meeting asked how necessity and effectiveness of the provision would be reviewed. One of the written responses also made a similar comment but reference specifically the need to consider the provision's role as part of the wider landscape of Special Educational Needs provision. Officers confirmed at the consultation meeting that there would be a post implementation review and that after that a number of aspects of the provision would be considered annually. The review process will take into consideration the wider impact of the implementation of the Strategic Plan for SEND Education Provision 2018-23.

6.3 Skilled Staff and Specialist Resources

Several responses made reference to there being a real need for this kind of specialised provision for primary aged pupils. One response stated that they thought it was important that the primary provision was hosted separately from the existing secondary provision. Officers confirmed that the provision is to be located separately to the secondary provision. Three responses specifically mentioned that they felt the Scarborough PRU staff had the appropriate staff to meet the needs of the pupils within the proposed provision.

6.4 <u>Number of Places Available</u>

One respondent asked whether the number of spaces available could be increased from 5 places if required. Officers confirmed that 5 places is indicative and that this is one of a number of aspects of the provision would be considered annually. The review process will take into consideration the wider impact of the implementation of the Strategic Plan for SEND Education Provision 2018-23.

6.5 <u>Response from the Scarborough Pupil Referral Unit Management Committee</u> The PRU Management Committee's response set out how they are already successfully supporting primary aged pupils as set out in the proposal. They expressed the view that the staff are well qualified and well trained and that following evaluation of the current provision, including positive feedback from parents, they were in support of the proposal.

7.0 FINANCIAL IMPLICATIONS

7.1 As noted in 6.1 the Local Authority is supporting the PRU with actual costs accrued from maintaining the provision for primary pupils. Therefore, there is not envisaged to be any negative implications for the PRU. This financial support will be a cost to the Local Authority's High Needs Block budget.

8.0 LEGAL IMPLICATIONS

- 8.1 For maintained schools the School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013 set out the manner in which prescribed alterations could be made. This is the process that NYCC would follow for changes of age range in maintained schools. However, Pupil Referral Units are not maintained schools and the process for making changes to these provisions is not prescribed in legislation or guidance.
- 8.2 In order to ensure fairness and consistency the Local Authority has consulted upon the proposal regardless of not being required by statute to do so. It is noted that the proposal consulted upon lowered the age to 4-16. However, it has been clarified that the duty on Local Authorities within Section 19 of the Education Act 1996 to make suitable alternative education for children who cannot attend school because of illness, exclusion or for any other reason, only applies for compulsory school age, that is the term after the child's 5th birthday. It is not the intention for Early Years Foundation Stage children to be included within this provision at the PRU and the age range in the proposed recommendation has therefore been amended from 4-16 to 5-16.
- 8.3 An Equalities Impact Assessment has been completed in relation to this proposal and it is included as Appendix 4. The assessment found there were no adverse impacts for those with protected characteristics. There were positive impacts found for those with disability in having their needs met within the setting where they had been excluded.

9.0 REASONS FOR RECOMMENDATION

9.1 Scarborough Pupil Referral Unit has historically had an age range of 11-16 and it is predominantly pupils within this age range who have required this type of provision. However, there have also been a small number of pupils aged under 11 who have been excluded and have required an alternative provision. In these circumstances a number of different provisions in primary schools have provided places. In 2019 it was considered by officers that the expertise of the PRU was best suited to provide these places to the younger pupils. For the last year the PRU has temporarily accommodated a number of pupils aged under 11 and it is now the view of officers that this should be formalised as a longer term arrangement until at least such time that the SEND Strategic Plan is fully implemented.

- 9.2 It is essential that the Local Authority maintains options to provide provision for primary aged pupils who are excluded from school. The number of places required is likely to be very low and it is unlikely that the Scarborough PRU would support more than five primary age pupils at any one time.
- 9.3 The PRU is considered the most appropriate provision to lead on the education of this younger group of pupils. The staff and leadership at the PRU have the necessary professional skills and primary education training to meet the needs of these pupils. At the last Ofsted inspection in 2018 the provision was judged 'Good' and the effectiveness Leadership and Management was judged 'Outstanding'. This proposal is being made with the support of the Leadership at the Scarborough PRU.
- 9.4 This change will not affect the capacity of the Pupil Referral Unit but will change the age range of pupils who will make up the pupil roll.
- 9.5 The consultation yielded a number of positive responses that supported the recommendation and the reasons for the recommendation from a variety of stakeholders.

10 HUMAN RIGHTS IMPLICATIONS

10.1 There are no Human Rights issues in relation to this proposal.

11 **RECOMMENDATIONS**

11.1 The Executive Member for Education and Skills is recommended to approve the proposal to lower the age range of Scarborough Pupil Referral Unit from 11-16 to 5-16, from 31 August 2021.

Background

Local authorities are responsible for arranging suitable full-time education for permanently excluded pupils, and for other pupils who – because of illness or other reasons – would not receive suitable education without such provision. This applies to all children of compulsory school age resident in the local authority area, whether or not they are on the roll of a school, and whatever type of school they attend. Full-time education for excluded pupils must begin no later than the sixth day of the exclusion.

Pupil Referral Units (PRUs) are a type of alternative provision which educates pupils who are unable to access mainstream schooling for any of the reasons set out above.

Although located in Scarborough town the PRU provides education to pupils from across the Scarborough District.

The Proposal

The PRU is considered the most appropriate provision to lead on the education of this younger group of pupils. The staff and leadership at the PRU have the necessary professional skills and primary education training to meet the needs of these pupils. At the last Ofsted

inspection in 2018 the provision was judged 'Good' and the effectiveness Leadership and Management was judged 'Outstanding'. This proposal is being made with the support of the Leadership at the Scarborough PRU.

Record of Public Meeting concerning Scarborough Pupil Referral Unit Meeting held on 18 January using Microsoft Teams – 19:00

1. Welcome

Matt George, Strategic Planning Officer at NYCC welcomed everyone to the meeting and invited Chris Reynolds to open the meeting.

2. Presentation

Chris Reynolds gave a brief presentation setting out the rationale for the proposal as described in the consultation document. He explained how the change of Age Range that was being proposed fitted into the context of the wider Strategic Plan. Matt George, Strategic Planning Officer provided context for some of the slides explaining the process for making this change and how people could respond. Chris Reynolds then opened up the meeting for questions from attendees.

3. Questions and Answers

<u>Elaine Mallen</u> stated that the PRU was already providing support to Primary Schools in the area and this change was building on is already being done.

<u>One member of the Management Committee</u> raised the point that they felt it was important that it was ensure that the PRU had the financial stability to meet the needs of pupils. She mentioned particularly the context of the recent restructure and that it was imperative that this proposal was supported financially

<u>Chris Reynolds</u> responded to say that a specific staffing structure for the Primary provision had been identified and that the Local Authority was supporting the PRU with the actual costs associated with this provision. He said that this included staff costs, leadership costs and premises costs.

<u>Another member of the Management Committee</u> asked about the review of this provision and how that would be done.

<u>Chris Reynolds</u> said that there would be a post implementation review and that after that a number of aspects of the provision would be considered annually. The review process will take into consideration the wider impact of the implementation of the Strategic Plan for SEND Education Provision 2018-23.

<u>Chris Reynolds</u> thanked the management committee members and the Headteacher for attending and closed the meeting at 19:30.

Yes	From my own experience as a long serving local primary headteacher, I would fully endorse the urgent need for this primary aged provision for permanently excluded pupils. Sadly, across the Scarborough and Whitby area, many schools have seen a significant increase in pupils experiencing severe social, emotional and mental health traumas which often cause these pupils to face crisis in mainstream primary schools. From personal experience, having had managed moves from local pupils into Wheatcroft who have been permanently excluded, despite the very best efforts of staff to create bespoke leaning provision, these pupils rarely manage to integrate into the mainstream system. I would hope that the proposed primary PRU would have access to the best professional expertise including counsellors and educational psychologists to help these vulnerable youngsters to find an appropriate and successful route through their education. It would be also be good to have more access to local special school places which primary age pupils could access without having to be permanently excluded. No Headteacher would exclude a pupil unless it was the last resort. Unfortunately, primary staff are being faced with greater violence and challenge then 5 ,10 or 20 years ago so our provision must evolve to meet these increasing needs. Although, the number of permanently excluded primary aged pupils is mentioned, detail is not provided of the exact numbers. This would make the proposal clearer for the rationale behind setting up the 4-11 year old provision. It would also be helpful having the number of permanent exclusion. Yes	Scarborough PRS (The Bridge) was asked to deliver provision for primary aged pupils following closure of EMS and are doing so. Teaching and support Staff (ELSA) are qualified for this age range and have been trained through a sustained CPD programme to deliver this very specialist provision. All pupils are baselined academically and through the Boxall profile and Thrive schemes to identify barriers and needs. Staff are experienced in using and tracking a range of interventions. We know what works. Monitoring has shown pupils to make progress from the baseline in reading, writing, maths and PSED and impact is regularly evaluated. Parental feedback is positive. This feedback has been fully discussed at January Management Committee and this feedback is submitted on behalf of the whole MC. The change is to lower the age range of the Scarborough Pupil Referral Unit which in practice will mean that a small number of pupils aged under 11 who have been excluded and have required an alternative provision will be able to access provision at the unit.

The PRU has plans in place for a dedicated staff group to run the primary provision created by this proposal. The staff and leadership at the PRU have the necessary professional skills and primary education training to meet the needs of these pupils.

There was a consultation period between 12 January and 23 February with all identified stakeholders. During this period there was also a virtual consultation meeting. Although Governors of the PRU attended this meeting there was no engagement from any other stakeholders or responses to the consultation.
