Dear Licensing

We would like to request an extension of our minibus which at renewal will be over the 10 Year vehicle age limit per the council policy.

This bus has been owned by ourselves from new and has been well maintained in our tenure. As per licensing legislation it has undergone all the necessary MOT's/ Compliance required in the 10 year period. Many of these tests have been carried out by the councils testing team at Dean Road when this was a council requirement.

We were previously planning to apply to extend two minibuses but instead have replaced one. From doing this we have managed to extract any parts which were cosmetically better and replace parts which were looking dated due to general wear and tear from the trade. This improves the aesthetic of the for future use.

During the period of covid we as a company closed down for 4 months and stored our vehicles. The minibus in question was hardly ever used in any period until all lockdown restrictions were lifted. This was due to limits on the numbers allowed to mix. It therefore hasn't had the full use it could of done in its licenced period due to this. Throughout this period all our vehicles including this one were always taxed and insured with no break despite the financial strain on the business not having an income to support this.

This vehicle is predominantly used on school contracts for additional needs and is a true asset to the business. The children transported are very attached to "their black bus" and can cause an unsettled atmosphere for them when it is ever in for maintenance as they don't like change.

The cost of replacing a like for like vehicle has become extremely expensive in recent times and a shortage of overall units available is not helping this issue.

We are still feeling the effects of covid as are many businesses and the period since has been a long climb back for us. An extension on this vehicle would

safeguard the jobs of certain drivers and passenger assistants and allow us to financially strengthen our business to find a suitable replacement in due course. The absence of this vehicle will make it difficult for us to continue certain NYCC contracts we currently undertake.
