Good morning, Charley and Sophie,

Thank you for taking the time to speak to me earlier today, as you are aware I am the Licensing Officer for Harrogate, and part of my role is to process all licensing applications that are submitted to North Yorkshire Police in our role as a responsible authority (as defined by the Licensing Act 2003).

I would ask that you accept this e-mail as both an acknowledgement to your communication and the formal response.

In assessing this application, I have considered the licensing objectives and the police would seek the following conditions for Hidden Wines Limited in addition to those offered in your application to mitigate the risk of Crime and Disorder and Public Nuisance at the premises.

Licensing Objectives

The Prevention of Crime and Disorder

Public Safety

The Prevention of Public Nuisance

The Protection of Children from Harm

Conditions agreed with North Yorkshire Police

1. Alcohol may only be sold on-line/Internet or by telephone.
2. The Premises Licence Holder shall install an auditable mechanism to verify that only customers 18+ are capable of purchasing alcohol via the company's on-line portal.
3. Alcohol shall only be delivered to a recognised commercial or residential address. Orders for delivery to a highway or public open space are not permitted.
4. The premises will operate as a storage unit for alcohol, alcohol sold online/telephone and delivery-based service, and there will no access permitted to members of the public.
5. All deliveries shall be made by a reputable courier or parcel delivery service, or by the premises licence holder or other drivers employed and/or authorised to make deliveries

- by the premises licence holder (Taxi companies will not be authorised to make deliveries). Where alcohol purchases are delivered by or on behalf of the premises licence holder, the premises licence holder shall ensure that the courier operates a Challenge 25 scheme.
6. Where the courier believe that the recipient is under 25 years of age, no delivery shall take place until such time as the courier has established that the person receiving the alcohol is over 18 years of age.
 7. Such confirmation shall be by way of the production of photographic ID. The only acceptable form of identification shall be a current Passport, photo card Driving Licence, Military ID card, or identification carrying the PASS logo (until other effective identification technology e.g. thumb print or pupil recognition, is adopted by the Premises Licence Holder)
 8. Records of purchases shall be retained for a minimum of 12 months (date of transaction), and shall be made available for inspection at the request of a responsible authority (Licensing Act 2003).
