<b>Title of proposal</b>	Household Support Fund – Phase 6
<b>Brief description of proposal</b>	To deploy a sixth allocation of Household Support Fund allocation to provide support to households in need who would otherwise struggle to pay essential utility bills, buy food or meet other essential living costs. The £3.54m allocation is being made available to NYC by DWP to cover the period October 2024 to March 2025. It is proposed that funding will be provided via a household direct award of supermarket vouchers, food banks, energy support, NYLAF, and support for care leavers.
