Brief description of proposal	The 2025/26 school funding consultation proposals relate to the following: <ul style="list-style-type: none">• The level of the minimum funding guarantee (MFG) protection. This determines the minimum funding change that a school will receive in terms of funding per pupil between the 2024/25 financial year and the 2025/26 financial year.• The methodology to be used to deal with any funding surplus or shortfall on the 2025/26 schools' block Dedicated Schools Grant (DSG) after the calculation of school budgets.• A transfer of 0.5% funding from the Schools Block DSG to the High Needs budget for the 2025/26 financial year
