# 1.0 Purpose of Report

This is to ensure that sufficient time can be given to each discussion and also to ensure that the ask of the Mayor's office is not overly burdensome.
- 7.0 All full Panel meetings will continue to be held in person and venues are highlighted on the programme where these have been confirmed.
