What are the desired outcomes?	<p>The recommendations within the report will:</p> <ul style="list-style-type: none"> • provide clarity, transparency and consistency in the allocation and spending of CIL receipts • ensure CIL receipts are spent on infrastructure required to support development, in accordance with the CIL Regulations 2010 specifically as amended in September 2019 ('the CIL Regulations') • ensure CIL serves its purpose of supporting the delivery of the infrastructure necessary to support the development in North Yorkshire • meet regulations with regard to the approval and publication of the IFS

Please give details.	<p>The Community Infrastructure Levy (CIL) together with Planning Obligations (s106) represent sources of funding to provide additional infrastructure or services necessary to enable or support development.</p> <p>Such funding normally only represents a proportion of the total cost of the infrastructure. Therefore, additional funding from other sources may be required to deliver the infrastructure necessary. These sources could include Department for Transport via National Highways and Network Rail, Department for Education, and specific grants including Grant in Aid from Defra and Levelling up funding.</p> <p>CIL provides for an administration fee, as a process the administration is self-financing. There are no VAT implications (CIL is o/s for VAT)</p>
