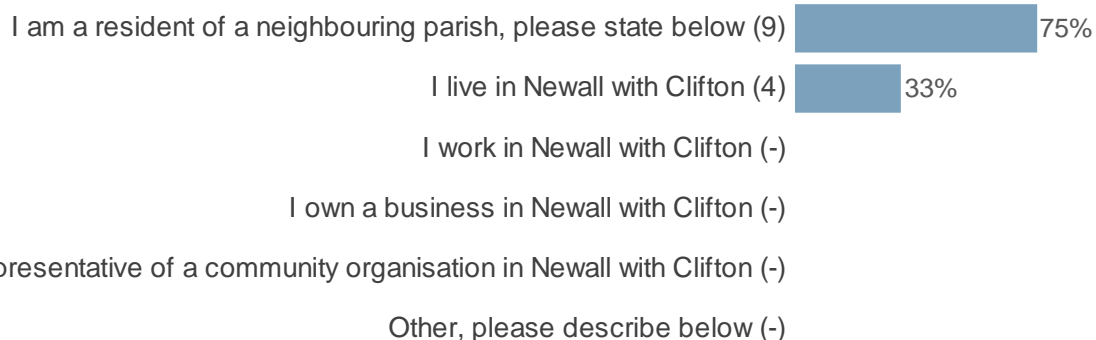


2025-26 CGR - Newall with Clifton

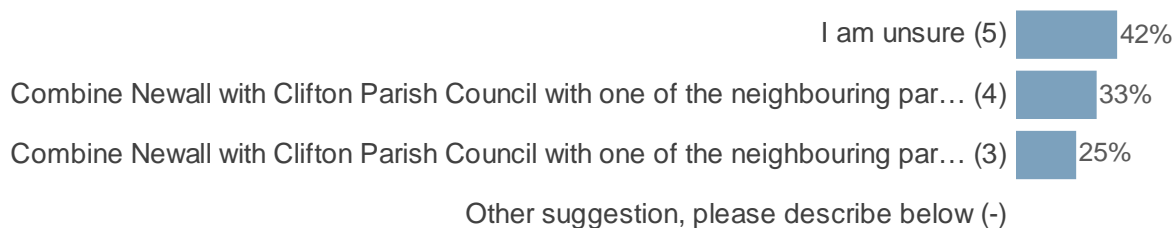

Ideally I would like us to have our own Parish council.

Waste of time having any Parish Council in this area. If you want to speak out, then you are risking your property being attacked with acid or burnt to the ground. Residents are not included for debate and land owners illegally get away with unlawful building and use of land, even when reported to the planning department at Harrogate.. In the past the only members on the Parish Council were there to make sure what they wanted was passed and after that left they removed access to the Parish Website so local residents had no idea what was going on. There are too many private secret meetings and those residents who would like to make a difference for the whole community are excluded from having any say.

Adjacent and willing to take on the parish - a natural fit.

We are both parish councils on the border of Otley and so have similar characteristics having a rural part but also close links to the town.

I think as N&C is relatively sparsely populated it has more in common with Farnley/Lower Washburn than mid Wharfedale. I also feel it seems to be a logical part of the Lower Washburn because the main road which runs through it is a connecting feature. Also, I believe at least part of it is within the Nidderdale 'National Landscape' and this also seems to be a good reason not to include it in a parish such as Mid Wharfedale which has no relationship to the 'National Landscape'

More natural fit

Geographically Mid Wharfedale is the nearest in proximity to Newall and Clifton. The Mid Wharfedale meetings are held in Askwith which is very new to Newall and Clifton.

I have lived here for 3 years and my understanding was that we were now linked with Askwith parish council but have not had any official indication

North Yorks ((Harrogate) has included land in C&N in their housing plan- in an area just north of Otley adjacent to Farnley Parish. It would make more sense from a number of perspectives related to this potential development to have C&N area in the same parish as Farnley.

Mid Wharfedale Parish Council is an active Parish Council, and is very open to members of the public.

We are geographically well spread out as a community..separate homes and groups of people and its hard to bring us all together. When we had a council we felt we had little support from Harrogate...but roadside verges and pavements are in places dangerous. So any help would be appreciated..thanks
