**Section 1. Please describe briefly what this EIA is about.** (e.g. are you starting a new service, changing how you do something, stopping doing something?)

A proposal to close (cease to maintain) Baldersby St James CE Primary School by Hope Sentamu Learning Trust. A 'Listening Period' with the community commenced on the 10 September 2021 and is due to finish on the 22 October 2021.

Section 2. Why is this being proposed? What are the aims? What does the authority hope to achieve by it? (e.g. to save money, meet increased demand, do things in a better way.)

There is a current proposal that the School should close on 31 August 2022. The process has now reached the public 'Listening Period'. The listening period is an opportunity for stakeholders and interested parties to be provided with information as to why the school is closing and how it is proposed the school closure will operate. Likewise, it is an opportunity for stakeholders and interested parties to submit their views on how the school closure process can be best managed.

As Baldersby St James CE Primary School is designated as a Rural Academy School, the LA is required to provide our view on the proposal. This is the first proposed closure of an academy in North Yorkshire. The LA considers that an EIA is necessary in order to consider the expected impact of the proposed change on all individuals with protected characteristics under the Equality Act 2010.

The County Council is under a statutory duty to ensure there are sufficient school places in the area, promote high educational standards, ensure fair access to educational opportunity and promote fulfilment of every child's educational potential.

#### Section 3. What will change? What will be different for customers and/or staff?

It is proposed that Baldersby St James CE Primary School should close with effect from 31 August 2022.

North Yorkshire County Council's Executive is being asked to propose that revised catchment area arrangements would be consulted on such that from September 2022:

- The northern part of the Baldersby St James catchment area (Baldersby Civil Parish) including Baldersby village should become part of the catchment area for Carlton Miniott Primary Academy
- The southern part of the Baldersby St James catchment area (Rainton with Newby Civil Parish) including Rainton village should become part of the catchment area for both Dishforth CE Primary School and Topcliffe CE Academy.

The process has now reached the public 'Listening Period'.

As Baldersby St James CE Primary School is designated as a Rural School, the LA is required to provide our view on the proposal.

Baldersby St James CE Primary School is designated as a rural school under the Designation of Rural Primary Schools (England) Order. Making significant changes to an open academy and closure by mutual agreement' <u>Making significant changes to an open academy and closure by mutual agreement (publishing.service.gov.uk)</u> (the Guidance) contain a presumption against closure of rural schools. This means that both the department and the LA need to agree the closure of a rural academy, and where the school is designated as having a religious character the trustees of the school and appropriate religious authority (in the case of church schools the diocese or relevant diocesan board) also need to agree to closure. The statutory guidance specifically states that 'This does not mean that a rural school will never close, but the case for closure should be strong and a proposal must be clearly in the best interests of educational provision in the area.'

Careful consideration to alternatives to closure of the school, including transport implications, increase in the use of motor vehicles which is likely to result from the closure of the academy, and the likely effects of such increase, the likely impact of the closure on the local community, including the loss of the building as a community facility and the impact on local people and the wider community has been given. An analysis of these issues is contained in the School Closure Proposal Baldersby St James CE Primary School report to Executive of 12 October 2021.

This proposal may be considered to have an adverse impact for those pupils currently on roll at the school as they would have to move to an alternative a school, as set out above in Section 7.

Monitoring of standards will be carried out through the County Council's School Improvement Team (for LA maintained schools) and through Ofsted inspections. Monitoring of sufficiency of school places in the Thirsk Outer Area will be undertaken by the CYPS Strategic Planning Team.
