DISPENSATION

On 4 July 2017, a dispensation was granted by North Yorkshire County Council's Monitoring Officer, under delegated powers, to:

COUNTY COUNCILLOR DAVID CHANCE

to enable him to speak, vote and be included within the quorum at meetings of the Yorkshire Coast and Moors County Area Committee when it is considering business relating to the Whitby Park and Ride Scheme and parking zone arrangements for Whitby.
